The following meeting will be held back at the Rood Center, on Sept. 14 (special election day).

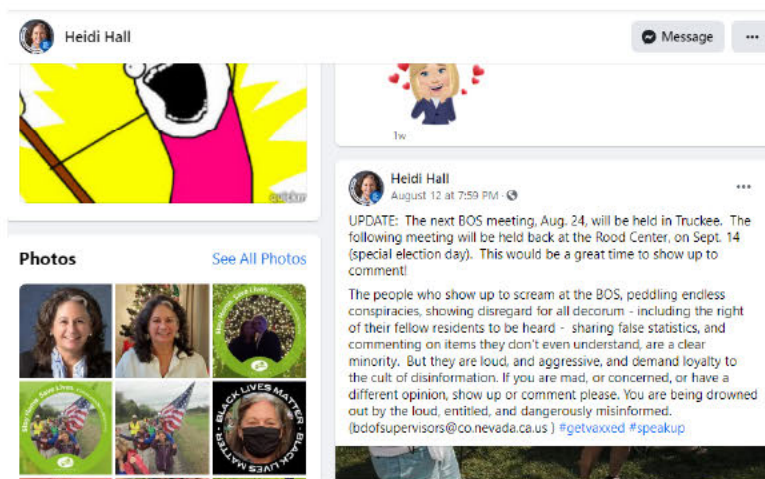
This would be a great time to show up to comment!

Since the BOS are elected representatives of our county, I would think you would all support the effort for public commentary and discourse. However, recent actions from a board member as well as our current Public Health Officer has proven otherwise.

I was extremely disappointed when I saw a FB post by Heidi Hall who apparently deems anyone with a different view on current circumstances as “dangerous”, and that we “demand loyalty to the cult of disinformation”. It’s disheartening to know that this is the reproach that is taken to many of us simply requesting more transparency. Our community deserves it and our children definitely do.

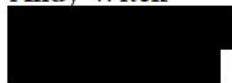

Scott is a wonderful person with a great deal of compassion in addition to his worldwide expertise in the medical field. Dr. Kellerman was the right choice for a public health director and is very dedicated to helping our community. He should not be forced to resign over making a small and joking off the cuff comment taken out of context regarding medical officers during the Spanish Flu over 100 years ago. Nevada County is very fortunate to have Dr. Kellerman and it does not serve our community to ask him to step down.

Hello, my name is Rachel Snyder, my family and I live in district 1, and I am a death worker/educator and until quite recently, worked as a funeral counselor for one of the two local mortuaries. Over the last 3 years, I have had over 600 families in my care, that includes approximately 2/3 of the covid casess, and more of last year's fentanyl and suicide cases than I care to count. I am writing this to express my gratitude to Dr. Kellerman, and adamantly disagree with even the suggestion that he leave his position.

I have spent literally hours writing and rewriting this. Every time I feel I'm being concise and impactful, I trail off and ramble into hundreds and hundreds of words trying to express the profound isolation, disrespect, gaslighting and betrayal I've experienced over the course of the last 17 months. The job I found so fulfilling, the sacrifices I made and risks I took, and forced my family into taking, because I felt such a deep ethical obligation to stay at my post. The anger and disgust I fight to control when the entitled restaurant owners and delusional and dishonest media vacuums and political agitators and pouty lipped grifters do their best to poison our community for their own selfish agendas. The fear that's growing by the day that my child will become ill because I'm forced to send him to school with the children whose parents intentionally send their kids sick.

I will save the well spoken stories and wise warnings from the world that most people try to ignore for another day, and another venue. I will say this.

I was willing to sacrifice my life and the safety of my family, when I could have easily walked in the beginning, I felt an ethical obligation to stay the course. After a year of being abused in stores, gaslit and endangered by the community I served? I finally lost my faith in my neighbors, and walked away from the job I loved... let someone else worry about who will pick up the bodies.

What happens if the death workers (which have a head count of less than 25) get sick or quarantine, or get tired of serving a community that mocks them and calls them liars? Who will clean up the reality that so many people in this county want to aggressively erase by shouting it down?

The lies, theatrics, harassment, false whistleblowing, and exploitation demonstrated by the deafening zealot minority has reached a fever pitch, and no sane, rational person is going to attempt to make a public comment when they have to run a gauntlet of vindictive, maskless, belligerent people to fight for their rightful turn at the mic.

Please don't allow this unconscionable "revolt" wear down any more of your essential workers, or yourselves.

Dr. Kellerman, there are thousands and thousands of us that know your integrity is solid, and trust you to guide us out of this. We are your patients, neighbors, and friends.

To the BOS, while I haven't always agreed with you I've decisions, I can't imagine trying to conduct any sort of business, much less navigate a global emergency and an infectious disease outbreak with the three-ring circus aggressing you relentlessly. I believe in freedom of speech but at some point these meetings have to become safe again for the rest of us. We are too busy trying to keep our children safe from disease and preparing for shut offs and wildfires to elbow our way through these delusional, dishonest zealots, and many are afraid to speak up lest they get targeted for harassment in their private lives and at their places of work.

The vast majority of us, including you, are being held hostage, and it's a hostile takeover. We expect you to protect the community from this with all the power you legally possess, and we expect you to protect our beloved public health official, who has done more good in the world than all of us put together.

I have more to say about my year in the trenches, but not today. Today, I want to focus on shutting down this ridiculous attack on the last person who deserves it. Ken Paige has no place pointing out anyone for inciting violence or targeting anyone. His hyperbolic holy war against an attempt to save lives so he can pack his restaurant have been duly noted by those of us in the community who are having to clean up the mess.

Our patience is gone, and essential workers are at a breaking point. Please consider the consequences of our health care system breaking down, which is not nearly as far away as you think.

This is a letter to be read for a public comment. I am writing in support of public health measures to curtail the spread of the pandemic. I have a unique position of having several medical conditions that lead me to not be advised to vaccinate, One of which is a past vaccine reaction. So I understand people who are hesitant or resistant to vaccines, and I wholeheartedly believe in medical choice. However I'm in the minority among unvaccinated locals as I've taken the pandemic very seriously, only socialized outdoors and not during peak outbreaks, never unmasked indoors, regularly test after potential exposures or any symptoms (even a few tests to make sure smoke related symptoms are just that). I urge you on both sides to consider that there are ways to be responsible to stop the spread without being vaccinated, although I do feel grateful for those who have made that choice to vaccinate.

I have been glad to see options presented in local venues and at the high school to offer alternative measures to stop the spread - including testing and quarantine options. I'm in support of universal indoor masking, and I would love to see testing requirements extend to the vaccinated as well as there are a fair number of breakthrough cases we've seen locally. I would love to see frequent testing options for healthcare workers along with more quality PPE. I hope that free testing continues to be available and abundant and than you all for your efforts navigating this time.
