RESOLUTION ACCEPTING AWARD OF THE CALIFORNIA DEPARTMENT OF CANNABIS CONTROL LOCAL JURISDICTION RETAIL ACCESS GRANT IN THE AMOUNT OF \$275,000.00

WHEREAS, the Nevada County Board of Supervisors met on January 25 through 27, 2023, at the Board of Supervisors Workshop and developed the 2023 Board of Supervisors Objectives for Nevada County that were adopted by Resolution No. 23-068; and

WHEREAS, Resolution 23-068 established cannabis under the Economic Development Objective initiative "Support potential high growth sector development"; and

WHEREAS, pursuant to the Budget Act of 2022, the California Department of Cannabis Control (DCC), issued a Notice of Funding Availability on March 10, 2023, for the Cannabis Local Jurisdiction Retail Access Grant Program; and

WHEREAS, at their regular meeting of April 18, 2023, the Board of Supervisors of the County of Nevada authorized application for the California Department of Cannabis Control Retail Access Grant in the amount of up to \$320,500.11 by Resolution 23-152; and

WHEREAS, the Nevada County Community Development Agency, including the Economic Development Office, Planning Department, and the Cannabis Compliance Division sought funding to explore the development of a local cannabis retailer licensing program in the unincorporated areas of Nevada County; and

WHEREAS, grant objectives include the development of a retail licensing program within the unincorporated areas of Nevada County, provisions to assist equity applicants, allowances for retail storefront dispensaries and non-retail storefronts delivery, allowances for adult-use and medicinal commercial cannabis access; and

WHEREAS, the grant has been awarded to Nevada County and revenues will be deposited to Community Development Agency Department in the amount of \$275,000.00; and

WHEREAS the use of grant funds in the amount of \$200,000.00 will provide direct support to plan and develop the development of a local cannabis retailer licensing program in the unincorporated areas of Nevada County along with making other updates to the Nevada County Cannabis Ordinance; and

WHEREAS, the County of Nevada also received an additional \$75,000.00 Phase I Equity Bonus from the California Department of Cannabis Control, which will be used to assist local equity applicants and licensees through its local equity program for commercial cannabis activity as described in its application for grant funds. NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Nevada authorizes the Community Development Agency Director of the County of Nevada to execute by electronic signature on behalf of the County of Nevada the grant agreement with the California Department of Cannabis Control, Cannabis Local Jurisdiction Retail Access Grant, including any extensions or amendments thereof and any subsequent grant agreement with the California Department of Cannabis Control in relation thereto, and accepts the award for the Cannabis Local Jurisdiction Retail Access Grant funding in the amount of \$275,000.00 to be deposited into the Cannabis Compliance budget 1123-20711-326-1000/445090.

IT IS AGREED that any liability arising out of the performance of this grant agreement, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The California Department of Cannabis Control and the State of California disclaim responsibility for any such liability.

IT IS AGREED that the County of Nevada agrees to abide by the terms and conditions of the Grant Agreement as set forth by the Department of Cannabis Control.

Local Cannabis Retail Permitting Plan

Completed Efforts

What steps have already been taken, if any, to develop a local cannabis retail licensing program?

It is the mission of the Cannabis Compliance Division to work in partnership with the community to permit and maintain a safe and environmentally responsible cannabis industry. Cannabis is a high priority under Nevada County's Economic Development initiative to "Support high potential growth sectors." The legalization of cannabis creates remarkable future business opportunities, however not everyone who has made a living in the past is currently able to thrive in the legal industry. In addition, access to safe regulated adult-use or recreational-use cannabis is limited in unincorporated Nevada County. Given the limitations for citizens of Nevada County to access a safe regulated cannabis product, the following steps have been taken to develop a local cannabis retail licensing program. The Nevada County Board of Supervisors directed Planning Division staff to assess and develop an ordinance to allow retail store front sales dispensaries and mobile retail sales delivery in existing commercial and industrial districts. The direction by the Board of Supervisors came after multiple discussions with staff at a January 28, 2023, Board workshop. The intent of the Board of Supervisors is to allow citizens to access retail cannabis products in locations that can be easily accessed and are near retail goods and services location that they already patronize. Nevada County plans to develop a draft ordinance identifying the allowance of retail store front sales dispensaries and mobile retail sales delivery in commercial and industrial zoning districts. The proposed draft ordinance will: 1) be circulated for public comment and will then be brought to the Planning Commission, and to the Board of Supervisors for adoption, 2) will develop necessary materials, including initial zoning clearance, application materials, and a competitive application review process, and 3) will develop the framework for a competitive review panel and a third party consultant selection process to administer and distribute equity grant funding. The Nevada County Board of Supervisors recently adopted Ordinance 2516 which became operative on February 9, 2023. This ordinance allows for retail sales and mobile delivery sales with an Administrative Development Permit or a Use Permit from sites that have licensed cultivation occurring. To date, the Planning Division has not had an application submitted or held an applicant planning consultation appointment. Significant limitations in the development of retail sales and mobile delivery sales have prevented applicants from submitting applications. A reason for this is the fact Nevada County's rural location and remote cultivation sites are not near urban centers. Additionally, because cultivation sites are often accessed by dirt and unimproved roads, accessibility for the consumer is limited due to commute time and road surfaces only allowing access by vehicles designed to travel rough terrain. The decline in the cannabis market prices has limited funds from potential applicants to expand from cultivation into the sales market. Exacerbating the decline in market conditions, development costs associated with expanding into the sales marketplace are a significant deterrent currently. There isn't one simple formula that holds the secrets of success for cannabis, but there are things that may provide an advantage. As the Cannabis Division continues to build its program, we can expect more consistency and structure in retail offerings. The goal of the Cannabis Division is to follow best practices in cultivation, compliance, processing, and distribution ensuring

the full scale of services are available for Nevada County that ensures the cannabis industry can scale and flourish.

RESOLUTION AUTHORIZING THE NEVADA COUNTY ECONOMIC DEVELOPMENT OFFICE, OR THEIR DESIGNEE, TO SUBMIT A GRANT APPLICATION FOR UP TO \$320,500.11 TO THE CALIFORNIA DEPARTMENT OF CANNABIS CONTROL FOR THE CANNABIS LOCAL JURISDICTION RETAIL ACCESS GRANT PROGRAM

WHEREAS, the Nevada County Board of Supervisors met on January 25 through 27, 2023 and developed the Board's 2023 Objectives for Nevada County that were adopted by Resolution 23-068; and

WHEREAS, Resolution 23-068 established cannabis under the Economic Development Objective initiative "Support potential high growth sector development"; and

WHEREAS, the Nevada County Board of Supervisions on January 28, 2023, directed staff to initiate and address future ordinance amendments to identify and include the allowance of retail store front sales dispensaries and mobile retail sales delivery in commercial and industrial zoning districts; and

WHEREAS, pursuant to the Budget Act of 2022, California Department of Cannabis Control's (CDCC), issued a Notice of Funding Availability (NOFA) on March 10, 2023, for the Cannabis Local Jurisdiction Retail Access Grant Program; and

WHEREAS, the Nevada County Economic Development Office, with direction from the Community Development Agency, Planning Division and Cannabis Compliance, is seeking funding to develop and implement a local cannabis retailer licensing program in the unincorporated areas of Nevada County; and

WHEREAS, the Board of Supervisors of the County of Nevada (Applicant) supports the submission of a Cannabis Local Jurisdiction Retail Access Grant application package (Application) on the forms provided by the CDCC; and

WHEREAS, successful applicants may be eligible for an additional Phase I Equity Bonus; and

WHEREAS, grant objectives include the development of a retail licensing program within the county's unincorporated areas, provisions to assist equity applicants, allowances for retail storefront dispensaries and non-retail storefronts delivery, allowances for adult-use and medicinal commercial cannabis access.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Board of Supervisors hereby approves and authorizes the Economic Development Program Manager or their designee to submit a grant application to the California Department of Cannabis Control (CDCC), Cannabis Local Jurisdiction Retail Access Grant for up to \$320,500.11 (up to \$216,136) PHASE I with potential for (\$104,364.11) Phase I Equity Bonus).
