OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AN APPLICATION FOR FUNDING AND THE EXECUTION OF A GRANT AGREEMENT AND ANY AMENDMENTS THERETO FROM THE 2020 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM- CORONAVIRUS RESPONSE ROUND 1 (CDBG-CV1) NOTICE OF FUNDING AVAILABILITY DATED JUNE 5, 2020

WHEREAS, the California Department of Housing and Community Development (HCD) announced the availability of approximately \$18.7 million in funding for the Community Development Block Grant (CDBG) Coronavirus Response Round 1 (CDBG-CV1) funding for local assistance; and

WHEREAS, the CDBG-CV1 application was due August 31, 2020, and the Health and Human Services Agency (HHS) received authorization to apply for funding per Resolution 20-357 on August 11, 2020; and

WHEREAS, this CDBG-CV1 funding is made available pursuant to the Coronavirus Aid, Relief, and Economic Security Act; and

WHEREAS, upon authorization and approval by the Board of Supervisors HHS prepared and submitted an application in the amount of up to \$257,134, the maximum available for Nevada County; and

WHEREAS, the Board approved a request by HCD to amend the original Resolution to meet specific funding requirements, per Resolution 21-003 on January 12, 2021; and

WHEREAS, HCD has revised the Subsistence Payment program to provide rental assistance; and

WHEREAS, upon receipt of a grant agreement, the Director of Health and Human Services, or designee, is authorized to sign the standard agreement with the State of California for the purposes of this grant.

NOW, THEREFORE, BE IT RESOLVED by the County Board of Supervisors of the County of Nevada as follows:

SECTION 1:

The Nevada County Board of Supervisors has reviewed and hereby approves the submission to the State of California of one or more application(s) in the aggregate amount, not to exceed, of \$257,134 for the following CDBG-CV1 activities pursuant to the June 5, 2020, CDBG-CV1 Notice of Funding Availability (NOFA):

SECTION 2:

The County hereby approves the use of Program Income in an amount not to exceed \$0 for the CDBG-CVI activities described in Section 1.

SECTION 3:

The County acknowledges compliance with all state and federal public participation requirements in the development of its application(s).

SECTION 4:

The County hereby authorizes and directs the Director of Health and Human Services, to execute and deliver all applications and act on the County's behalf in all matters pertaining to all such applications.

SECTION 5:

If an application is approved, the Director of Health and Human Services, or designee, is authorized to enter into, execute and deliver the grant agreement (i.e. Standard Agreement) and any and all subsequent amendments thereto with the State of California for the purposes of the grant.

SECTION 6:

If the application is approved, the Director of Health and Human Services or designee, is authorized to sign and submit Funds Requests and all required reporting forms and other documentation as may be required by the State of California from time to time in connection with the grant.
