OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING DISCRETIONARY APPOINTMENTS TO SPECIAL DISTRICT BOARDS

WHEREAS, on August 20, 2024, the Board of Supervisors adopted Resolution 24-477, appointing candidates who filed declarations of candidacy and faced no opposition to Special District Boards; and

WHEREAS, Elections Code section 10515 provides that the Board of Supervisors may appoint any remaining vacancies; and

WHEREAS, the following districts with remaining vacancies were notified by the Clerk of the Board that the Board of Supervisors was seeking qualified applicants to fill the upcoming vacancies: Mystic Mine Road Community Service District, Oak Tree Park and Recreation District, Rough and Ready Fire Protection District and Western Gateway Recreation and Park District; and

WHEREAS, a Public Notice of Insufficient Candidates was published in the Union Newspaper on October 15, 2024, and posted on county bulletin boards pursuant to Government Code section 549784 and placed on the County website; and

WHEREAS, applications were not submitted for the upcoming positions on Mystic Mine Road Community Service District, Oak Tree Park and Recreation District, and Western Gateway Recreation and Park District; and

WHEREAS, two applications were received for the upcoming position on the Rough and Ready Fire Protection District; and

WHEREAS, two applications were reviewed by Supervisor Hoek and the Rough and Ready Fire Protection District board with a recommendation made.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of Nevada County hereby appoints John Wetzel to the Rough and Ready Fire Protection District for four-year terms ending December 4, 2028.
