### OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AND AUTHORIZING THE CHAIR OF THE BOARD TO EXECUTE AN ENERGY PERFORMANCE MASTER CONTRACT WITH CLIMATEC LLC AND SUNPOWER CORPORATION, SYSTEMS TO IMPLEMENT A PROGRAM OF ENERGY CONSERVATION AND SOLAR ENERGY GENERATION AT VARIOUS NEVADA COUNTY FACILITIES


WHEREAS, Nevada County has followed the process provided for in California Government Code §4217 to procure the services of a qualified Energy Services Company, and through that process has selected Climatec LLC ("Climatec"); and

WHEREAS, Climatec has completed a comprehensive energy assessment of County facilities, and has recommended a Program comprising energy conservation measures and development of solar energy generation facilities at various County-owned properties; and

WHEREAS, the anticipated cost of the proposed energy program is less than the anticipated savings to the County for energy projected to be used in the facilities benefitting from the Program over the useful life of the proposed improvements; and

WHEREAS, a Notice of Public Hearing has been published in accordance with California Government Code Section 4217.12.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors approves and authorizes the Chair of the Board to execute, in substantially the form attached hereto, an Energy Performance Master Contract between the County of Nevada, Climatec LLC, and SunPower Corporation, Systems ("SunPower") providing for Climatic LLC to coordinate an Energy Conservation and Solar Energy Generation Program for which Climatec will be engaged by the County under separate Agreements to implement energy conservation measures, to perform measurement and verification services on said energy conservation measures, and to guarantee that the measures result in the anticipated level of energy cost savings to the County; and for which SunPower will be engaged by the County under separate Agreements to implement five solar energy generation projects, to perform operations and maintenance services on the completed solar projects, and to guarantee that the solar projects result in the anticipated level of energy cost savings to the County.

This Contract is comprised of the five (5) Agreements included in this document. The Agreements together define all of the required areas of responsibility within the Nevada County Energy Conservation and Solar Energy Generation Project ("the Project"). The Project is made up of two phases – Installation Phase and Operating Phase. Responsibility for project coordination for all services and activities through the completion of the Installation Phase of the project resides with Climatec LLC. All warranty obligations are the obligation of either SunPower or Climatec LLC, depending on the equipment or system involved. The price of the non-solar portion of the project is \$2,385,597.00. The price of the solar portion of the project is \$9,699,154.00

The Operating Phase follows immediately after the Installation Phase. Climatec LLC will be solely responsible for the Measurement and Verification and the savings guarantee related to the non-solar portion of the project and SunPower will be solely responsible for the Operations and Maintenance Agreement and Solar Performance Guarantee Agreement for the solar portion of the project.

The terms and conditions of the overall project are dependent on the project phase and type of work being done. Each of the five Agreements contain the terms and conditions that apply to that specific work. Payment terms are delineated in each of the agreements.

All terms and conditions of the Agreements are conditioned upon Purchaser obtaining financing to carry out the work described therein. In the event that Purchaser does not obtain financing at rates and under terms that make the Project cost effective, Purchaser will not issue a Notice to Proceed for the work and neither Purchaser, Climatec LLC, nor SunPower will be obligated to fulfill their obligations as described in the Agreements.

Overall project management during the installation phase of the project will be performed by Climatec LLC. Both Climatec LLC and SunPower will provide project management for their work, and coordination and supervision of the overall installation phase will be by Climatec LLC.
