OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION TO APPROVE THE COLLECTION OF PARCEL CHARGES FOR SOLID WASTE COLLECTION SERVICES IN WESTERN NEVADA COUNTY FOR FISCAL YEAR 2026/27 (DISTRICTS I-IV)

WHEREAS, the Director of the Department of Public Works has prepared the Parcel Charges for Fiscal Year 2026-2027 for Tax Rate Areas contained within the boundaries of Western Nevada County described in Nevada County Code Section 15.13.250; and

WHEREAS, the Parcel Charges are in conformance with Ordinance No. 2319 and as temporarily reduced per Resolution 25-232, which expires on June 30, 2027; and

WHEREAS, the reduced solid waste parcel charges rates remain unchanged and are as follows for Fiscal Year 2026-2027:

	Approved Reduced Rates
Single Family Residential	\$ 44.54 per year
Multi-Family Residential	\$ 34.70 per unit per year
Mobile Home Space in mobile home park	\$ 31.08 per unit per year
Non-Residential Parcel	\$ 27.18 per ton

WHEREAS, Government Code Section 25827 authorizes the collection of parcel charges for solid waste fees. Government Code Section 25823 allows for the collection of fees related to disposal facilities. Government Code section 25830(c) allows for the charges to be collected and placed on the secured tax roll.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors authorizes the collection of parcel charges for Fiscal Year 2026-2027 in the following Tax Rate Areas within the boundaries of Western Nevada County as described in Nevada County Code Section 15.13.250:
