RESOLUTION AUTHORIZING ENVIRONMENTAL CLEARANCE FOR THE 2022 HIGH FRICTION SURFACE TREATMENT PROJECT

WHEREAS, the 2022 High Friction Surface Treatment Project proposes the application of High Friction Surface Treatment (HFST) to various road curves throughout Nevada County; and

WHEREAS, Highway Safety Improvement Program (HSIP) funds are available for this project; and

WHEREAS, under Section 15301(c) of the CEQA Guidelines, Class 1 projects consisting of the repair, maintenance, or minor alteration of existing public facilities involving negligible, or no expansion of use are categorically exempt from the provisions of the California Environmental Quality Act.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors of the County of Nevada authorizes the Director of the Nevada County Department of Public Works to file a Notice of Exemption with the Nevada County Clerk-Recorder's Office for the 2022 High Friction Surface Treatment Project.

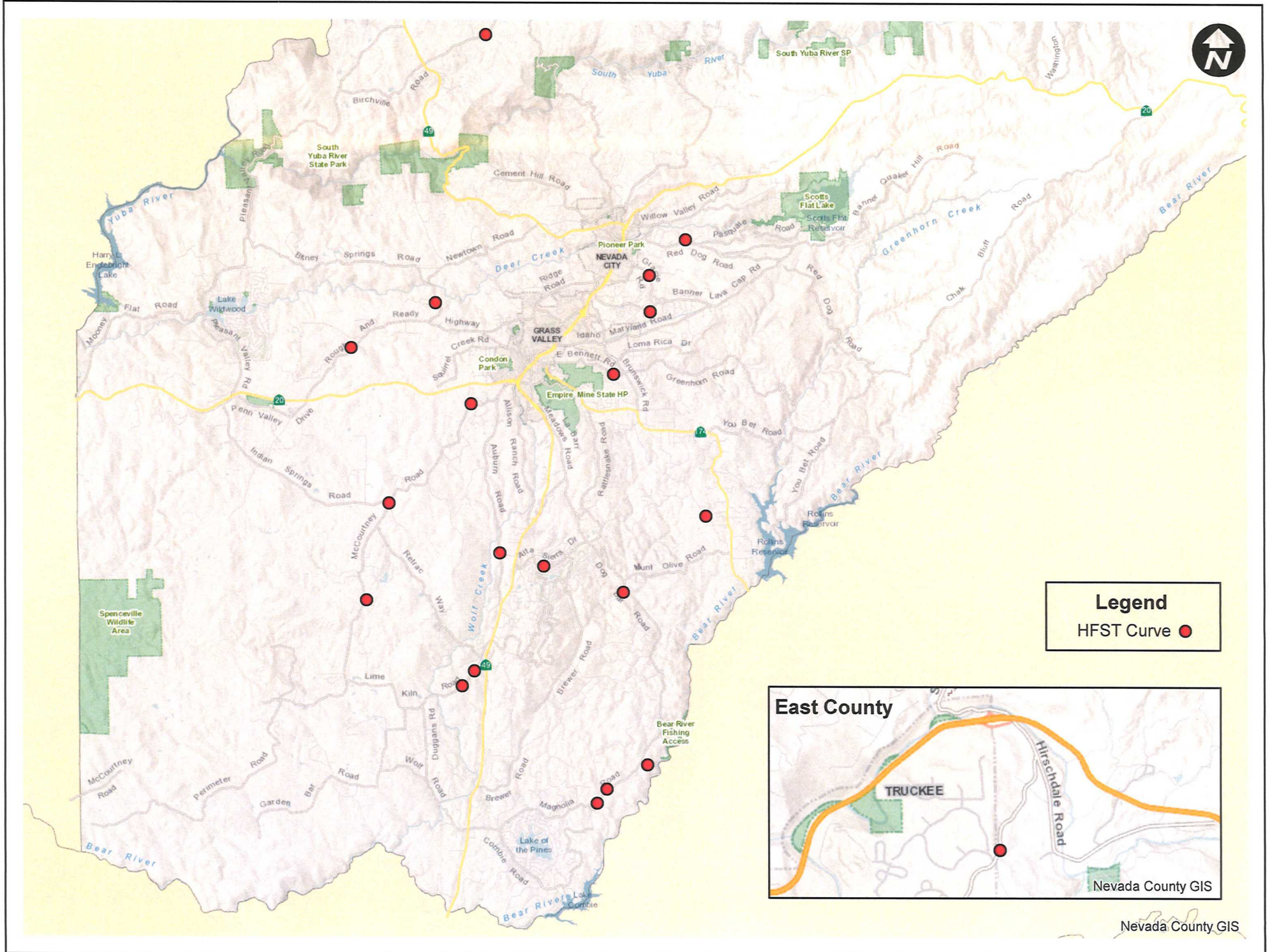
