OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING THE RENEWAL CONTRACT WITH SHONA TORGRIMSON D/B/A HELPING HANDS NURTURING CENTER, FOR NURTURING PARENTING PROGRAM AND SUPERVISED VISITATION SERVICES FOR FAMILIES AND STAFF TRAINING FOR CHILD WELFARE SERVICES, WITH THE MAXIMUM CONTRACT PRICE OF \$380,000 FOR THE TERM OF JULY 1, 2026, THROUGH JUNE 30, 2028, NOT TO EXCEED \$190,000 FOR THE TERM OF JULY 1, 2026, THROUGH JUNE 30, 2027, AND NOT TO EXCEED \$190,000 FOR THE TERM OF JULY 1, 2027, THROUGH JUNE 30, 2028

WHEREAS, Child Welfare Services (CWS) is required to provide Prevention and Early Intervention strategies that provide for the safety and permanency for children and services that target the overall well-being of families, ensuring that the critical needs of children and families in the child welfare system are met; and

WHEREAS, under this agreement, Helping Hands Nurturing Center (Contractor) will continue to provide Nurturing Parenting Program (NPP) and Supervised Visitation Services for CWS families; and

WHEREAS, the NPP services are family-centered initiatives designed to build nurturing parenting skills. The long-term goals are to:

- 1) Prevent recidivism in families receiving social services;
- 2) Lower the rate of teenage pregnancies;
- 3) Reduce the rate of juvenile delinquency and alcohol abuse; and
- 4) Stop the intergenerational cycle of child abuse by teaching positive parenting behaviors.

WHEREAS, Contractor will provide specialized training for CWS staff on the Helping Hands Supervised Coaching Visitation Model.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Professional Services Contract by and between the County and Shona Torgrimson d/b/a Helping Hands Nurturing Center for the provision of Nurturing Parenting Program services as referred by Child Welfare Services, for the term of July 1, 2026, through June 30, 2028, in the total maximum amount of \$380,000, not to exceed \$190,000 for fiscal year 2026/27, and \$190,000 for fiscal year 2027/28, be and hereby is approved in substantially the form attached hereto and that the Chair of the Board of Supervisors be and is hereby authorized to execute the contract on behalf of the County of Nevada. This contract is contingent upon the adoption of the FY 26/27 County Budget. The contract begins on July 1, 2026.
