OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 1 TO THE AGREEMENT WITH NORTH VALLEY BEHAVIORAL HEALTH, LLC FOR ACUTE PSYCHIATRIC INPATIENT SERVICES AT THE CONTRACTOR'S PSYCHIATRIC HEALTH FACILITY TO INCREASE THE MAXIMUM CONTRACT PRICE FROM \$2,000,000 TO \$3,000,000 (AN INCREASE OF \$1,000,000) TO COVER THE INCREASED NUMBER OF PLACEMENTS AND REVISE THE AGREEMENT TO REFLECT THE INCREASE IN THE MAXIMUM CONTRACT PRICE FOR THE CONTRACT TERM JULY 1, 2024 TO JUNE 30, 2026 (RES. 24-257)

WHEREAS, on June 11, 2024, per Resolution No 24-257, the Nevada County Board of Supervisors authorized the execution of the renewal Agreement between the County of Nevada and North Valley Behavioral Health, LLC pertaining to the provision of acute psychiatric inpatient services for County referred clients; and

WHEREAS, to address the increased number of placements, the parties desire to amend the Agreement to increase the maximum contract price from \$2,000,000 to \$3,000,000 (an increase of \$1,000,000) and revise the Agreement to reflect the increase in the maximum contract.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 1 to the Agreement by and between the County and North Valley Behavioral Health, LLC pertaining to the provision of acute psychiatric inpatient services for County referred clients increase the maximum amount of the agreement from \$2,000,000 to \$3,000,000 (an increase of \$1,000,000) for the contract term of July 1, 2024, through June 30, 2026 and amend and revise the Agreement to reflect the increase in the maximum contract price be and hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.

**AMENDMENT NO. 1 TO THE AGREEMENT WITH
NORTH VALLEY BEHAVIORAL HEALTH LLC (RES 24-257)**

THIS AMENDMENT is dated this June 3, 2025 by and between NORTH VALLEY BEHAVIORAL HEALTH LLC, hereinafter referred to as "Contractor" and COUNTY OF NEVADA, hereinafter referred to as "County." Said Amendment will amend the prior agreement between the parties entitled Agreement, executed on June 11, 2024 per Resolution No. 24-257; and

WHEREAS, the Contractor provides services pertaining to the provision of acute psychiatric inpatient services referred clients; and

WHEREAS, in order to address the increased number of placements, the parties desire to amend their agreement to increase the Contract Maximum Price in paragraph 3 from \$2,000,000 to \$3,000,000 (an increase of \$500,000 for Fiscal Year 24/25 and an increase of \$500,000 for Fiscal Year 25/26 for a total increase of \$1,000,000), and revise Agreement to reflect the increase in the maximum contract price and new contract term.

NOW, THEREFORE, the parties hereto agree as follows:

1. That Amendment #1 shall be effective as of March 1, 2025.
2. That the Contract Maximum Price set forth in paragraph 3 shall increase from \$2,000,000 to \$3,000,000 (an increase of \$500,000 for Fiscal Year 24/25 and an increase of \$500,000 for Fiscal Year 25/26 for a total increase of \$1,000,000).
3. That the Agreement amended to the revised Agreement attached hereto and incorporated herein.
4. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
