OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 2 TO THE STANDARD AGREEMENT NUMBER 20F-3668 WITH THE STATE DEPARTMENT OF COMMUNITY SERVICES AND DEVELOPMENT (CSD) FOR FUNDING OF 2020 COMMUNITY SERVICES BLOCK GRANT (CSBG) FUNDED BY THE CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY (CARES) ACT TO EXTEND THE AGREEMENT TERM THROUGH AUGUST 31, 2022 AND REPLACE: ARTICLE 5, PROGRAM BUDGET REQUIREMENTS AND PAYMENTS, ARTICLE 6, FINANCIAL REPORTING, ARTICLE 7, CSBG TERMS, CONDITIONS, PROGRAMMATIC PROVISIONS, AND REPORTING, IN THEIR ENTIRETY; FOR THE TERM OF MARCH 27, 2020 THROUGH AUGUST 31, 2022 (RES. 20-331) (RES. 20-475)

WHEREAS, Federal legislation was passed known as the Coronavirus Aid, Relief, and Economic Security (CARES) Act to provide financial assistance due to the Covid 19 pandemic; and

WHEREAS, the State Department of Community Services and Development's (CSD) received an allocation of CARES funding to provide assistance to low income individuals and families impacted by the Covid 19 pandemic; and

WHEREAS, per Resolution No. 20-331, the Board of Supervisors approved the Standard Agreement 20F-3668 to receive CARES funding from CSD through a Community Services Block Grant (CSBG), in the maximum amount of \$379,283 for the term of March 27, 2020, through May 31, 2022, through Agreement Number 20F-3668 and was subsequently amended November 10th, 2020, per Resolution 20-475 to modify Article 7 of the original Agreement and increase the maximum award amount to \$419,653; and

WHEREAS, the County is in receipt of Amendment No. 02 to the Agreement which modifies Article 5, 6 & 7 of the Agreement and extends the Agreement termination date to August 31, 2022.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Nevada County Board of Supervisors of the County of Nevada, State of California, that the Amendment No. 2 Agreement 20F-3668 by and between the County and CSD pertaining to awarding the County of Nevada CARES CSBG funds to support services to improve the conditions of low-income residents directly impacted by the Covid 19 pandemic, extending the Agreement termination to August 31, 2022, replacing Article 5, Program Budget Requirements and Payments, Article 6, Financial Reporting Article 7, CSBG Terms, Conditions, Programmatic Provisions, and Reporting, in its entirety, for the term of March 27 2020 through August 31, 2022, be and hereby is approved in substantially the form attached hereto and that the Chair of the Board of Supervisors is hereby authorized to execute the Amendment on behalf of the County of Nevada.

BE IT FURTHER RESOLVED that Ryan Gruver, Health and Human Services Agency Director, is authorized to sign any required documents associated with CSD notifications to allow for receipt of CSBG funds up to the maximum amount of \$419,653 for the term of March 27, 2020, through August 31, 2022.
