OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NUMBER 1 TO THE AGREEMENT PESH3596 BETWEEN THE COUNTY OF NEVADA AND TYLER J. MCSWEENEY, DBA GEARED UP DRIVE TRAIN, FOR THE REPAIR OF VEHICLES FOR NEVADA COUNTY FLEET SERVICES INCREASING THE AMOUNT OF THE CONTRACT TO A NEW MAXIMUM AMOUNT NOT TO EXCEED \$42,000, AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE CONTRACT AMENDMENT

WHEREAS, in July 2018, the Nevada County Purchasing Agent executed a service contract PESH3596 between Nevada County and Tyler J McSweeney for repair County vehicles which is effective July 1, 2018 and will expire on June 30, 2019; and

WHEREAS, the original contract amount for \$25,000 is being increased to a total contract amount not to exceed \$42,000 to cover costs additional unexpected repairs; and

WHEREAS, these repairs exceeded the original estimated maintenance and repair budget. The repair costs will be a direct reimbursement by Fleet Management; and

WHEREAS, there is sufficient budget in the Fiscal Year 2018/19 Fleet Services budget. 4291-92005-704-2000 / 520900; and

NOW, THEREFORE, BE IT RESOLVED that the Nevada County Board of Supervisors, on behalf of the County of Nevada, approve Amendment No. 1 with Tyler J McSweeney, increasing the maximum contract amount to a new amount not to exceed \$42,000 and authorizes the Chair of the Board to execute the amendment.

**AMENDMENT TO PERSONAL SERVICES AGREEMENT WITH TYLER J.
MCSWEENEY DBA GEARED UP DRIVE TRAIN**

THIS AMENDMENT is executed this 14th day of May 2019 by and between Tyler J. McSweeney, dba Geared Up Drive Train and the COUNTY OF NEVADA. Said Amendment will amend the prior agreement PESH3596 between the parties entitled Personal Services Contract for Repair of Automotive Drive Train for Nevada County Fleet Services executed on July 1, 2018 by the Purchasing Director.

WHEREAS, the County has encountered the need for unexpected repairs of County vehicles which were not contemplated in the original Agreement; and,

WHEREAS, the parties now desire to increase the Maximum Contract Amount to cover the cost of providing these additional services; and,

WHEREAS, the original contract was executed by the Purchasing Agent and the proposed amendment will exceed the purchasing agent's signing authority.

NOW, THEREFORE, the parties hereto agree as follows:

1. This amendment shall be effective as of May 14, 2019.
2. That Section 2 of the Agreement, Maximum Contract Price, is hereby increased by \$17,000, for a total Maximum Contract Price of \$42,000;
3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
