**BACKGROUND:**

Currently, there is one member vacancy for the Citizen's Oversight Committee of the Nevada County Library. One member vacancy for unexpired four-year term March 31, 2025. This vacancy and position were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers bulletin board, the Board of Supervisors office, and the County website. Notice was also posted at the Truckee Town Hall and District V Board of Supervisors office in Truckee.

Violet Nakayama submitted an application for appointment to the Citizen's Oversight Committee of the Nevada County Library on May 14, 2024. Violet is not a current resident of Nevada County, however; she resides in Truckee in Placer County on the border. The Citizen's Oversight Committee of the Nevada County Library amended their bylaws by vote at their November 25, 2024, meeting to clarify the appointment of one member whose primary residence is located in the United States Postal Service ZIP code 96161 residing in either the County of Nevada or the County of Placer.
