OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION ACCEPTING A CONTRIBUTION FROM THE CENTER FOR THE ARTS IN THE AMOUNT OF \$59,000 FOR INSTALLATION OF NEW SEATING AT THE GRASS VALLEY VETERANS MEMORIAL BUILDING AND RECOGNIZING THEIR FUNDRAISING THAT ENABLED THE PURCHASE AND INSTALLATION OF THE SEATS, EACH DEDICATED TO A VETERAN OR ACTIVE DUTY MILITARY PERSONNEL

WHEREAS, through Resolution 13-184, the County of Nevada entered into an Agreement with the Center for the Arts of Grass Valley, California, to improve the upper level seating at the Grass Valley Veterans Memorial Building; and

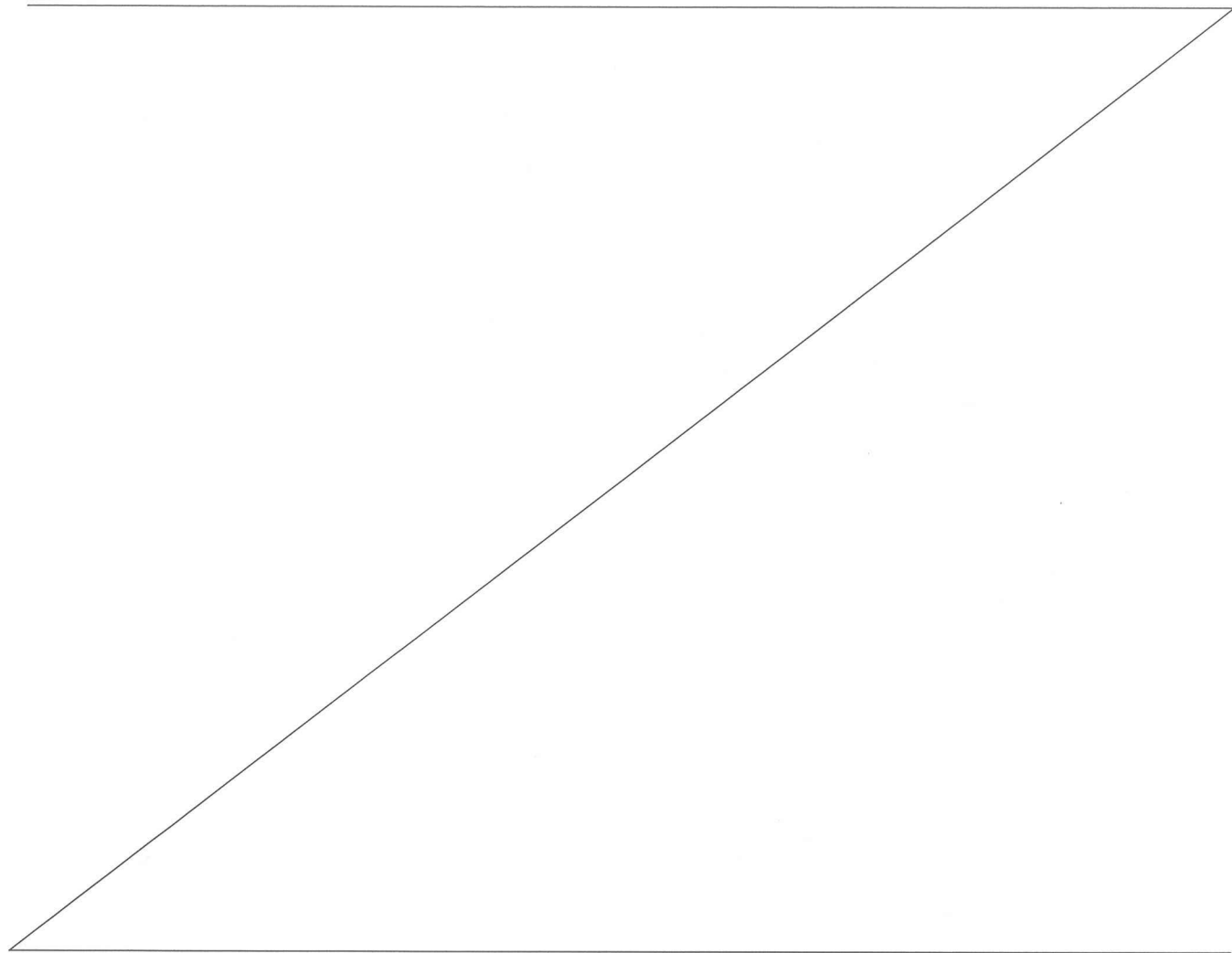
WHEREAS, the Center for the Arts conducted a fundraising campaign to fund the purchase, installation, and dedication of new seating with each seat bearing a plaque dedicated to a Veteran or active duty military personnel; and

WHEREAS, the County installed the seating and the Center for the Arts raised sufficient funds to reimburse the County for the installation cost of the seating in accordance with the Agreement; and

WHEREAS, the Center for the Arts has donated all right, title, and interest in the seating and dedication plaques to the County; and

WHEREAS, the County of Nevada desires to recognize the Center for the Arts of Grass Valley, California, for their contribution in the amount of \$59,000 for the new upper level seating and dedication plaques at the Grass Valley Veterans Memorial Building.

NOW, THEREFORE, BE IT RESOLVED, that the Nevada County Board of Supervisors accepts a contribution from the Center for the Arts in the amount of \$59,000 and recognizes the Center's generosity and partnership in improving the upper level seating and the dedication of each seat to a Veteran or active duty military personnel at the Grass Valley Veterans Memorial Building.
