



# **RESOLUTION No. 26-379**

## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

### **RESOLUTION AMENDING RESOLUTION 25-182 APPROVING THE OPERATIONAL AGREEMENT WITH CRISIS INTERVENTION SERVICES, TO INCREASE THE ANNUAL NOT-TO-EXCEED AMOUNT FROM \$3,500 TO \$5,500 FOR JULY 1, 2025, THROUGH JUNE 30, 2029, AND AMENDING THE FISCAL YEAR 2025/26 DISTRICT ATTORNEY BUDGET (4/5 AFFIRMATIVE VOTE REQUIRED)**

WHEREAS, the District Attorney's Office receives Marriage License Domestic Violence Surcharge Fees, pursuant to Welfare and Institutions Code section 18305 and Domestic Violence Court Fine revenues pursuant to Penal Code section 1203.097, which are required to be distributed to qualified domestic violence shelter-based programs; and

WHEREAS, Crisis Intervention Services operates a qualified domestic violence shelter-based program serving Eastern Nevada County residents and is eligible to receive these funds; and

WHEREAS, the District Attorney's Office has received additional revenue from these funding sources, and wishes to amend Resolution 25-182, to increase the annual not-to-exceed amount from \$3,500 to \$5,500; and

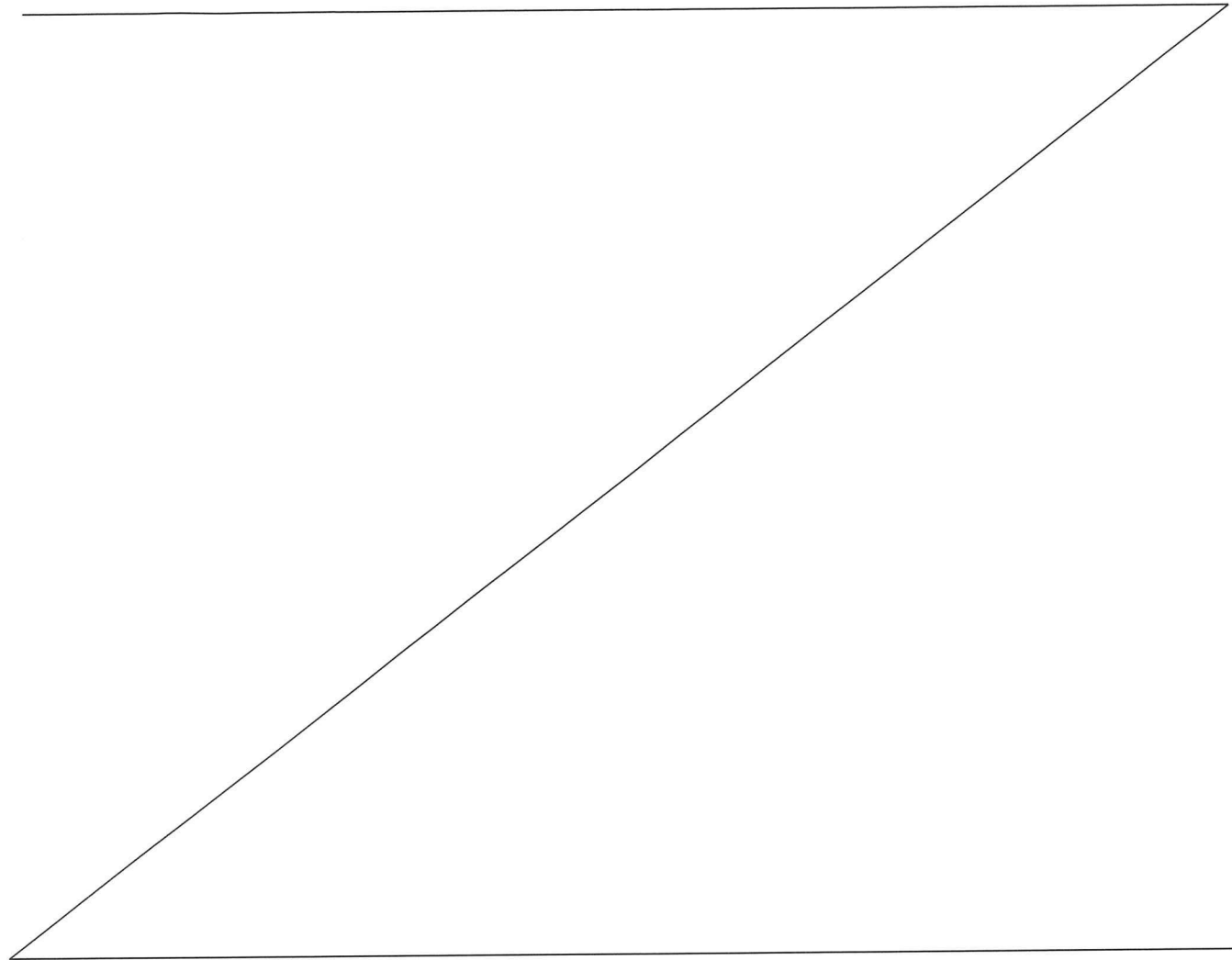
WHEREAS, except for the increase to the annual not-to-exceed amount on Resolution 25-182, the operational agreement shall remain unchanged.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Resolution 25-182 is hereby amended to increase the annual not-to-exceed amount from \$3,500 to \$5,500 for the period of July 1, 2025, through June 30, 2029, and the District Attorney, or their designee, is authorized to execute all documents necessary to implement this amendment.

BE IT FURTHER RESOLVED that the Board of Supervisors directs the Auditor-Controller to amend the fiscal year 2025/26 District Attorney budget (4/5 affirmative vote required) as follows:
