



# **RESOLUTION No. 24-437**

## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

**RESOLUTION APPROVING EXECUTION OF THE CALIFORNIA RADIO INTEROPERABLE SYSTEM (CRIS) TRUNKED RADIO SERVICE AGREEMENT WITH CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES, PUBLIC SAFETY COMMUNICATIONS (CAL OES/PSC) THAT WILL ALLOW THE COUNTY OF NEVADA TO JOIN CRIS, LEASE PUBLIC SAFETY RADIO EQUIPMENT AT NO COST TO CAL OES/PSC AND AUTHORIZES CAL OES/PSC TO INSTALL AND OPERATE NEVADA COUNT PUBLIC SAFETY RADIO EQUIPMENT AT SITE LOCATIONS**

WHEREAS, the Nevada County Sheriff's Office desires to maintain security and safety for the Public and its Law Enforcement Officers; and

WHEREAS, it is acknowledged that radio communications are a critical component of public safety in both normal and emergency operations; and

WHEREAS, the Sheriff's Office desires to replace and upgrade its current radio systems inclusive of mobile vehicle, handheld, and radio tower systems in a phased approach; and

WHEREAS the Sheriff's Office has obtained Congressional Directed Funding in the amount of \$4,800,000 towards the cost of this project; and

WHEREAS, on December 13, 2022, via Resolution 22-608, the Board authorized Phase 1 of the Sheriff's Office radio infrastructure improvement project, which consisted of replacing mobile vehicle, and handheld radios along with associated equipment with appropriate Motorola products in the amount of \$1,600,000; and

WHEREAS, on June 25, 2024, via Resolution 24-1181, the Board approved execution of Notice to Proceed letters with Motorola for the intent to purchase \$2,797,320 in Motorola equipment and services for Phases 2 and 3 of the radio infrastructure improvement project in order to lock in current pricing for Motorola equipment and the Sheriff's Office will be seeking further Board approval to purchase said equipment; and

WHEREAS, the Nevada County Sheriff's Office desires to lease at no cost to the California Governor's Office of Emergency Services, Public Safety Commission, the public safety radio equipment, and that Nevada County become a partnering agency in the CRIS system; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors, of the County of Nevada, State of California, that the California Radio Interoperable System (CRIS) Trunked Radio Service Agreement between the County of Nevada and California Governor's Office of Emergency Services, Public Safety Communications, pertaining to the leasing of public safety radio equipment and participation in the States's California Radio Interoperable System, is hereby approved, and authorizes the Sheriff or her designee to execute the Agreement on behalf of the County of Nevada.
