

RESOLUTION No. 24-396

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION AUTHORIZING FUEL PURCHASES FOR NEVADA COUNTY FLEET FROM HUNT AND SONS, LLC FOR AN ANNUAL NOT TO EXCEED TOTAL OF \$1,212,000 FISCAL YEAR 2024/25

WHEREAS, Fleet Services has need to purchase fuel from a commercial cardlock provider for all County vehicles, buses, trucks, and heavy equipment; and

WHEREAS, access to fueling stations must be located in both Western and Eastern County, as well as providing access to stations outside the County; and

WHEREAS, local fueling stations must be able to accommodate large vehicles, buses and trucks operated by Roads, Sanitation and Transit; and

WHEREAS, The Fleet Services Department collaborated with the Purchasing Team to leverage a competitively awarded agreement issued by the Department of General Services (DGS); and

WHEREAS, Hunt and Sons LLC was awarded Contract Id No. 1-23-91-02A for discounted fuel products that expires March 1, 2026; and

WHEREAS, Hunt and Sons, LLC can meet the Nevada County's fueling needs for multiple locations and station size throughout the County, while providing an out of town fueling network with over 236,000 stations nationwide through their participation in the CFN fueling network; and

WHEREAS, Hunt and Sons, LLC offers a \$0.14 margin discount that prices fuel for Nevada County at \$0.14 over the Oil Price Information Standard that has provided upward eighteen percent (18%) discount on retail fuel and this discount is applied at any CFN location.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Approves and authorizes the Purchasing Agent to issue a blanket purchase order to Hunt and Sons, LLC for the term of July 1, 2024, through June 30, 2025.

- 2. Approves one (1) renewal option July 1, 2025, through March 1, 2026, so long as the Department budget is approved at the fiscal year 2025/26 Budget hearing.
- 3. Authorizes the Purchasing Agent to encumber future fiscal year renewal.
