OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 1 TO THE PERSONAL SERVICES CONTRACT WITH PROJECT H.E.A.R.T. INC. TO PROVIDE ADDITIONAL COGNITIVE BEHAVIORAL THERAPY-BASED SERVICES FOR ADULTS AND JUVENILE PROBATION CLIENTS DURING FISCAL YEAR 2022/23

WHEREAS, in 2019 the Probation Department was awarded Federal Substance Abuse and Mental Health Administration (SAMHSA) grant to expand treatment services and programs to adults; and

WHEREAS, the Community Corrections Performance Incentive Act (SB678) allocates funding to implement and maintain evidence-based practices in adult felony probation supervision; and

WHEREAS, the Youthful Offender Block Grant allocates funding for the purposes of providing evidence-based programming, appropriate rehabilitative and supervisory services to youthful offenders; and

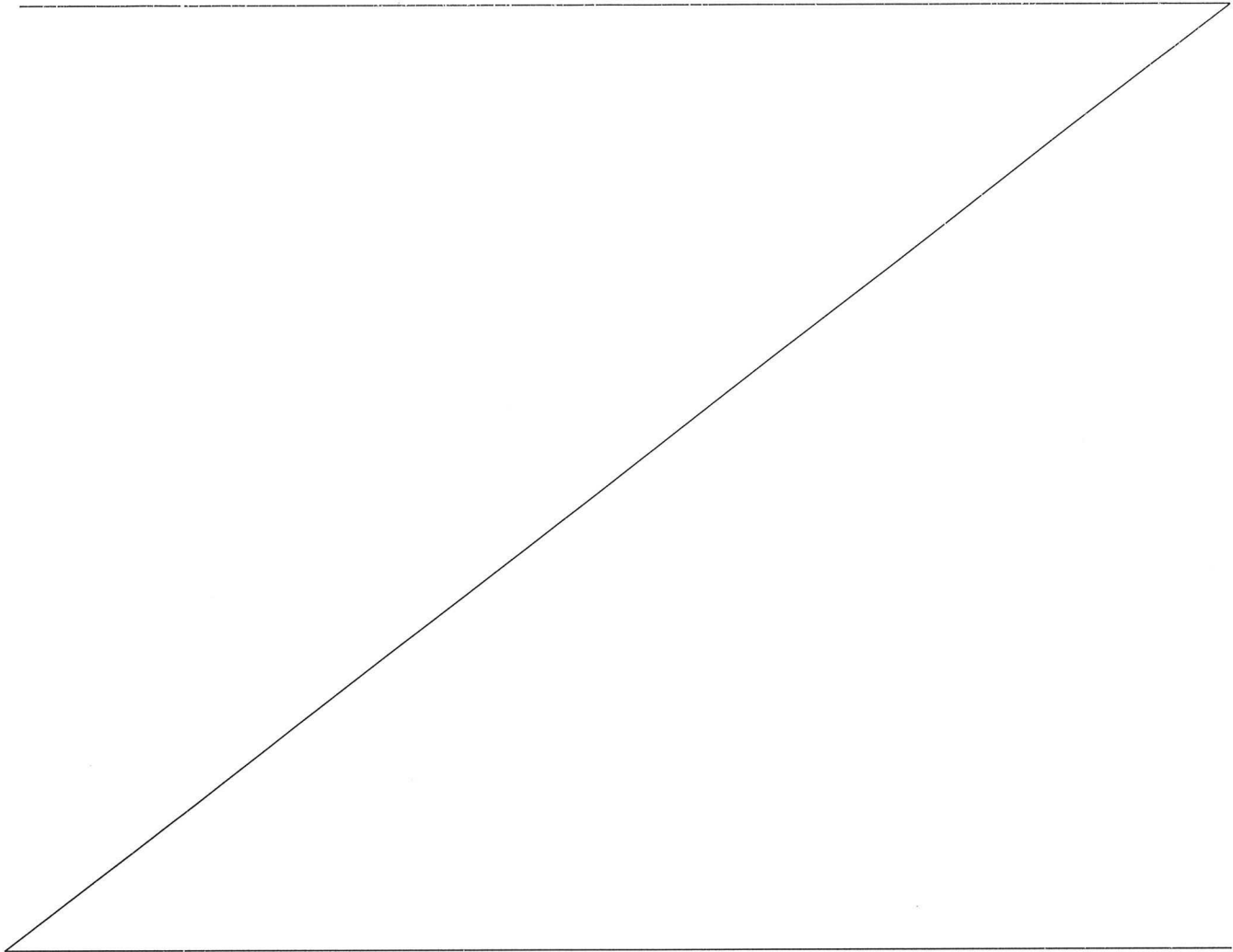
WHEREAS, Project H.E.A.R.T. provides cognitive behavioral therapy-based services for adults and youths; and

WHEREAS, the parties have previously entered into a Personal Services Contract dated July 1, 2022, which is set to expire on June 30, 2023, by Purchase Order Number PESQ4514.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors, of the County of Nevada, State of California, that Amendment No. 1 to the Personal Services Contract by and between the County of Nevada and Project H.E.A.R.T., Inc. pertaining to providing additional cognitive behavioral therapy based services for adults and juvenile probation clients in both a custodial and community setting, for the contract term of July 1, 2022, through June 30, 2023, increasing the maximum amount to \$100,000, be and hereby is approved and that the Chair of the Board of Supervisors is hereby authorized to execute the Amendment, effective January 1, 2023, on behalf of the County of Nevada. All services are funded by the SAMHSA grant, Community Corrections Performance Incentive Act (SB678) and Youthful Offender Block Grant (YOBG) funds.

Funds to be disbursed from 0101-20320-201-1000 / 521520 not to exceed the maximum contract amount of \$100,000.

BE IT FURTHER RESOLVED that the Nevada County Board of Supervisors hereby directs the Auditor-Controller to increase encumbrance number PESQ4514 from \$50,000 to \$100,000 for Fiscal Year 2022/23.



**AMENDMENT #1 TO PERSONAL SERVICES CONTRACT
WITH PROJECT HEART INC.**

THIS AMENDMENT is executed this 1st day of January, 2023 by and between Project H.E.A.R.T. Inc. and the COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties for the provision of peer mentoring, coaching and pro-social services for probation involved adults, executed on July 19, 2022, by Purchase Order Number PESQ4514.


WHEREAS, the parties desire to amend the contract amount from \$50,000 to \$100,000 to provide additional peer mentoring, coaching and pro-social services for probation involved adults and youth.

NOW, THEREFORE, the parties hereto agree as follows:

1. That this amendment shall be effective as of January 1, 2023.
2. That the enumerated services provided in Exhibit A be modified to include;
 - One on one meetings with CBT curriculum in the Placer County JDF
 - One on one meetings with CBT curriculum with referred Probation youth
 - One on one meetings with CBT curriculum in the Wayne Brown Correctional Facility
 - ADC CBT Groups with a maximum of 5 participants
 - CBT Groups held in the Wayne Brown Correctional Facility for Probation clients
3. That the enumerated agreed upon costs provided in Exhibit B be modified to include;
 - One on one meetings with CBT curriculum (youth and adults) \$90 per session
 - ADC CBT Groups\$90 first participant, \$30.89 per additional participant
 - WBCF CBT Groups\$90 first participant, \$30.89 per additional participant
 - Drive time to/from the Placer JDF \$90 per hour
4. That paragraph one (1) of Exhibit B maximum amount shall be increased to \$100,000.
5. That in all other respects the prior agreements of the parties shall remain in full force and effect except as amended herein.
