## GRANT AGREEMENT

### League of California Community Foundations Disaster Relief, Recovery and Resilience Fund

Pass Through Grant from Tahoe Truckee Community Foundation to Nevada County

The undersigned hereby agrees to the following grant conditions:

1. To use the funds only for the designated purpose as described in the grant application and subsequent grant notification letter and not for any other purpose without prior written approval of the League of California Community Foundations (League) and Tahoe Truckee Community Foundation (TTCF).
