RESOLUTION APPROVING AMENDMENT 1 TO THE CONTRACT BETWEEN THE COUNTY OF NEVADA AND ZAG TECHNICAL SERVICES, INC. TO EXTEND THE CONTRACT TERMINATION DATE FROM JUNE 30, 2020 TO JUNE 30, 2021, AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE AMENDMENT

WHEREAS, County computers and servers require ongoing maintenance to ensure County business is conducted on equipment that is properly secured and configured. To do so manually is labor intensive, and the management software was need to be successful in this task; and

WHEREAS, on June 25, 2019 the Board approved a contract with ZAG Technical Services, Inc. to provide these implementation, maintenance and consulting services in the amount of \$44,423.23 for the term of June 14, 2019 through June 30, 2020; and

WHEREAS, additional time is needed to complete the scope of work outlined in the original contract resulting in the need to amend the contract to extend the termination date to June 30, 2021.

THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 1 to the Contract between the County of Nevada and ZAG Technical Services, Inc to provide Information System Consulting Services to install, configure and tune the system management solution (Microsoft System Center) extending the contract termination date from June 30, 2020 to June 30, 2021 be and hereby is approved in the attached Amendment No 1 and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment behalf of the County of Nevada.
