



# **RESOLUTION No. 21-302**

## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

### **RESOLUTION APPROVING AMENDMENT NO. 9 TO THE AGREEMENT BETWEEN THE COUNTY OF NEVADA AND PARATRANSIT SERVICES FOR THE PROVISION OF SPECIALIZED PARATRANSIT SERVICES IN WESTERN NEVADA COUNTY**

WHEREAS, on May 14, 2013, the Nevada County Board of Supervisors adopted Resolution No. 13-168, approving a five-year contract with Paratransit Services for provision of specialized Paratransit Services in Western Nevada County that began on July 1, 2013 and expired on June 30, 2018; and

WHEREAS, on July 22, 2014, the Nevada County Board of Supervisors adopted Resolution No. 14-362, approving Amendment No.1 to the contract between Nevada County and Paratransit Services; and

WHEREAS, on August 11, 2015, the Nevada County Board of Supervisors adopted Resolution No. 15-392, approving Amendment No. 2 to the contract between Nevada County and Paratransit Services; and

WHEREAS, on July 26, 2016, the Nevada County Board of Supervisors adopted Resolution No. 16-381, approving Amendment No. 3 to the contract between Nevada County and Paratransit Services; and

WHEREAS, on October 11, 2016, the Nevada County Board of Supervisors adopted Resolution No. 16-491, approving Amendment No. 4 to the contract between Nevada County and Paratransit Services; and

WHEREAS, on August 15, 2017, the Nevada County Board of Supervisors adopted Resolution No. 17-438, approving Amendment No. 5 to the contract between Nevada County and Paratransit Services; and

WHEREAS, on July 17, 2018, the Nevada County Board of Supervisors adopted Resolution No. 18-375, approving Amendment No. 6 to the contract between Nevada County and Paratransit Services; and

WHEREAS, on August 27, 2019, the Nevada County Board of Supervisors adopted Resolution No. 19-481 approving Amendment No. 7 to the contract between Nevada County and Paratransit Services; and

WHEREAS, on June 23, 2020, the Nevada County Board of Supervisors adopted Resolution No. 20-261, approving Amendment No. 8 to the contract between Nevada County and Paratransit Services for a second two-year extension from July 1, 2020, through June 30, 2022; and

WHEREAS, the contract agreement contains a provision for an annual increase of the Paratransit Services contract price that includes both a fixed vehicle service hourly rate and a fixed monthly rate on July 1<sup>st</sup> of each contract year equivalent to the increase in the CPI (California Consumer Price Index, California Department of Industrial Relations, Division of Labor Research, All Urban Consumers) for the most recent available twelve month period prior to each scheduled increase in an amount of not less than one (1) percent, with a cap of three (3) percent annually, unless otherwise mutually agreed upon by both parties; and

WHEREAS, the California CPI calculation for the twelve-month period of April 2020 to April 2021 reports a 4.0 percent increase; and

WHEREAS, Nevada County and Paratransit Services wish to amend the contract agreement to include an overall maximum contract obligation increase of three (3) percent to \$1,620,592: inclusive of an increase of Paratransit Services' fixed vehicle service hourly rate to \$45.97 and an increase of the fixed monthly rate to \$64,562.00, per mutual agreement effective July 1, 2021, through June 30, 2022; and

WHEREAS, there is sufficient budget available in the FY 2021-22 Transit Services budget in account 4281-91003-707-1000/521520 to fund the contract.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Approves the attached Amendment No. 9, to increase the Paratransit Services' fixed vehicle service hourly rate to \$45.97, the fixed monthly rate to \$64,562, and the maximum contract amount to \$1,620,592.00, beginning July 1, 2021, through June 30, 2022.
2. Authorizes the Chair of the Board of Supervisors to execute on behalf of Nevada County the amendment between Nevada County and Paratransit Services.

**AMENDMENT NO. 9**

**PARATRANSIT SERVICES CONTRACT**


THIS AMENDMENT is executed this 13<sup>th</sup> day of July 2021, by and between PARATRANSIT SERVICES and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled Personal Services Contract between County of Nevada and Paratransit Services for Provision of Specialized Paratransit Services in western Nevada County, executed on July 1, 2013 by Resolution No. 13-168 and which agreement was subsequently amended on July 22, 2014 by Resolution Number 14-362, on August 11, 2015 by Resolution Number 15-392, on July 26, 2016 by Resolution No. 16-381, on October 11, 2016 by Resolution No. 16-491, on August 15, 2017 by Resolution No. 17-438, on July 17, 2018 by Resolution No. 18-375, on August 27, 2019 by Resolution No. 19-481, and on June 23, 2020 by Resolution No.20-261.

NOW, THEREFORE, the parties hereto agree as follows:

1. To increase the Paratransit Services' fixed vehicle service hourly rate to \$45.97 and the fixed monthly rate to \$64,562 from July 1, 2021 through June 30, 2022. This increase is set at the maximum of three percent.
2. The maximum contract amount not to exceed \$1,620,592.
3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
