SUBJECT: An Ordinance replacing in its entirety Chapter II, Article 11 of the Nevada County Administrative Code.

RECOMMENDATION: The proposed Ordinance was introduced at the October 24, 2023 Board of Supervisors' meeting. It is now recommended that the Board waive further reading and adopt the Ordinance replacing Chapter II, Article 11 of the Nevada County Administrative Code which will authorize the County of Nevada to join Partnership HealthPlan of California.

FUNDING: This Ordinance has no fiscal provisions, and no impact to the General Fund.

BACKGROUND:

In August of 2019, the State Auditor released a report entitled "Department of Health Care Services: It Has Not Ensured That Medi-Cal Beneficiaries in Some Rural Counties Have Reasonable Access to Care" that found several shortcomings in the provision of healthcare services to Medi-Cal recipients in rural counties and recommending that the California Department of Health Care Services (DHCS) assist counties in transitioning to the County Organized Health System (COHS) model. The COHS model is generally regarded as offering counties the greatest amount of local control, with counties being directly responsible for governance of their respective plans, either alone or in combination with other counties.

On August 24, 2021, Article 11 of Chapter II of the Nevada County Administrative Code was replaced in its entirety to authorize the County of Nevada to transition to a COHS model administered by Partnership HealthPlan of California. This will allow the implementation of a COHS in Nevada County as authorized by Welfare and Institutions Code section 14087.54, a transition that will take place on January 1, 2024. The next step in the process is to pass an amended Ordinance to include language for the appointment of a member from the County of Nevada to the Partnership HealthCare Plan of California Commission. This is a multi-county board comprised of commissioners appointed by the Board of Supervisors of each member county. Provisions of the amended Ordinance include authorization, appointee recommendations, term of office, and powers and duties of the Commission.
