EMERGENCY SERVICES GRANT AWARD VW25022601 FOR
THE VICTIM/WITNESS ASSISTANCE PROGRAM IN THE
AMOUNT OF \$352,770 FOR THE PERIOD OF OCTOBER 1, 2025,
THROUGH SEPTEMBER 30, 2026, AND AUTHORIZING THE
DISTRICT ATTORNEY, AND/OR GRANT SUBAWARD
AUTHORIZED AGENTS TO EXECUTE ALL REQUIRED GRANT
DOCUMENTS AND DIRECTING THE AUDITOR CONTROLLER
TO AMEND THE DISTRICT ATTORNEY FISCAL YEAR 2025/26
BUDGET (4/5 AFFIRMATIVE VOTE REQUIRED)**

WHEREAS, the Nevada County District Attorney's Office has been awarded the the California Office of Emergency Services (Cal OES) Victim Witness Assistance Program grant funding in the amount of \$352,770; and

WHEREAS, the Cal OES grant award is comprised of State Victim Witness Assistance Grant Funds (VWAO) in the amount of \$13,388.00, Victims of Crime General Funds (VCGF) in the amount of \$148,310.00 and Federal Victim of Crime Act (VOCA) Grant funds in the amount of \$191,072.00 and have been made available for the grant period of October 1, 2025 to September 30, 2026; and

WHEREAS, these funds will be used to provide services to victims and witnesses of crime as specified in California Penal Code sections 13835-13835.5, including crisis intervention and other comprehensive services for the victims and witnesses of crime in Nevada County; and

WHEREAS, the District Attorney, the Assistant District Attorney, and the Administrative Analysts are designated as Grant Subaward Authorized Agents, authorized to execute all required grant documents.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Nevada, State of California, hereby accepts the Cal OES Victim/Witness Assistance Program grant in the amount of \$352,770, for the grant period of October 1, 2025, through September 30, 2026 and that the District Attorney and/or the Grant Subaward Authorized Agents are hereby authorized to execute all documents required to comply with and fulfill the grant requirements.

BE IT FURTHER RESOLVED that the Board of Supervisors is directing the Auditor Controller to amend the fiscal year 2025/26 District Attorney budget as follows:
