OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 2 TO THE PERSONAL SERVICES AGREEMENT BETWEEN THE COUNTY OF NEVADA AND COUNTY OF SONOMA COUNTY TO HOUSE YOUTH FROM NEVADA COUNTY IN SONOMA'S YOUTH FACILITY IN THE AMOUNT NOT TO EXCEED \$56,500 FOR THE TERM JULY 1, 2026 THROUGH JUNE 30, 2027, AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE AMENDMENT.

WHEREAS, Senate Bill (SB) 823 announced the closure of the state Division of Juvenile Justice and the realignment of youth to the care of counties in the 2020 legislative session; and

WHEREAS, on May 14, 2021, the Governor signed SB 92, creating a "Secure Youth Treatment Facilities" track for youth found to have committed serious offenses; and

WHEREAS, non-realignment or non-secure track youth detained in Nevada County will still be detained at Placer County Youth Detention Facility primarily, as deemed appropriate; and

WHEREAS, Nevada County established a Juvenile Justice Realignment Block Grant Annual Plan that was approved by the Juvenile Justice Coordinating Council and accepted by the Board of Supervisors of Nevada County, per Resolution No. 21-525; and

WHEREAS, SB 823 Juvenile Justice Realignment Block Grant allocates funds to Nevada County for expenses related to these realigned youth; and

WHEREAS, Nevada County Probation made an Agreement with Sonoma County under Resolution 24-486 pertaining to housing and providing "Secure Track" detention and programming services to in-custody youth at the Sonoma County Juvenile Hall; and

WHEREAS, the Agreement was amended June 30, 2025, per Resolution 25-406, to increase the bed day rate to \$390 for fiscal year 2025/26, and this amendment increases the rate to \$403 per bed day for fiscal year 2026/27; and

WHEREAS, Nevada County intends to revisit this agreement on June 30, 2028, with the intention to address whether the terms of the Agreement remain in the best interest of Nevada County.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 2 to the Agreement by and between Nevada County and Sonoma County effective July 1, 2026, through June 30, 2027, is approved, and that the Chair of the Board of Supervisors is hereby authorized to execute the Agreement on behalf of the County of Nevada, contingent upon adoption of the fiscal year 2026/27 County Budget, and that the Auditor -Controller is directed to encumber \$56,500 for fiscal year 2026/27. Funds provided through SB 823 will be used to cover the expense related to this Agreement. This contract is contingent upon the adoption of the Fiscal Year 2026/27 County Budget.
