OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING ACCEPTANCE OF THE US DEPARTMENT OF JUSTICE OFFICE ON VIOLENCE AGAINST WOMEN (OVW) GRANTS TO IMPROVE THE CRIMINAL JUSTICE RESPONSE (ICJR) PROGRAM IN THE AMOUNT OF \$700,000 FOR THE PERIOD OF APRIL 1, 2026 THROUGH MARCH 31, 2029, AND AUTHORIZING THE DISTRICT ATTORNEY, OR THEIR DESIGNEE(S), TO EXECUTE ALL REQUIRED GRANT DOCUMENTS, AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE DISTRICT ATTORNEY FISCAL YEAR 2026/27 BUDGET (4/5 AFFIRMATIVE VOTE REQUIRED) (FEDERAL AWARD)

WHEREAS, the Nevada County District Attorney's Office has accepted a \$700,000 award from the U.S. Department of Justice, Office on Violence Against Women (OVW) Grants to Improve the Criminal Justice Response (ICJR) for the period of April 1, 2026, through March 31, 2029; and

WHEREAS, the ICJR Program supports coordinated community responses that provide services to victims of domestic violence, dating violence, sexual assault, and stalking; and

WHEREAS, victim/survivors of intimate partner violence in Nevada County face several barriers to accessing services, to include geographic isolation and transportation barriers, demonstrating a need for the services that would be provided by a Family Justice Center Program; and

WHEREAS, professionals within the Nevada County service provider community have long-identified the need for a centralized victim-services center and have recently mobilized in order to implement the vision; and

WHEREAS, funds from this program will support our County in establishing and staffing a multidisciplinary Family Justice Center.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Board of Supervisors hereby approves acceptance of the OVW Grant to Improve the Criminal Justice Response Program in the amount of \$700,000.00 for the period of April 1, 2026, through March 31, 2029, and authorizes the District Attorney, and/or their designee(s) to execute all required grant documents.

BE IT FURTHER RESOLVED that the Board of Supervisors directs the Auditor-Controller to amend the fiscal year 2026/27 District Attorney budget, contingent upon adoption of the Fiscal Year 2026/27 Budget, as follows:
