To the Nevada County BOS,

I am a resident in District 1, born and raised in Nevada County. I am writing in support of the temporary Urgency Ordinance regarding enforcement of the guidelines set forth to combat the swift spread of COVID 19. Our community had been commandeered by outside political agitators that seem to be taking advantage of a small handful of much-loved local businesses who are struggling, primarily restaurants. These businesses have been led to believe that they have some sort of legal, constitutional protection from the recent public health orders, and have decided to defy those orders.

I supported the "education not enforcement" stand taken by local government initially, but it seems as if this has only empowered this disturbingly growing sentiment that we are somehow immune from the pandemic overtaking many other towns and cities worldwide. This defiance is being encouraged and emboldened primarily by outsider fringe groups that have no deep understanding or love of our home or the people in it, and who do not have to stick around to experience the consequences.

To allow this to continue is detrimental to our safety, as well as our economy. The businesses that are not being compliant have been given accommodations that many that are following the orders operate without. They have been given many warnings and offers of education, as well as several platforms to express their concerns. Their refusal to row their side of the boat is alienating all of our downtown businesses as a concerned public local and otherwise reluctantly boycott them and subsequently their neighbors as well. It shows a complete disregard for our seniors, our disability community, our citizens with a myriad of health issues that renders them vulnerable, as well as our first responders, healthcare and deathcare workers who will be left to deal with the fallout.

There is no reason for the many to be sacrificed for the few, simply because they feel their livelihood is more valuable than anyone else's, and that their lives shouldn't be inconvenienced to save anyone else's. If there are no effective consequences to defying these emergency orders, why should the rest of us struggle so hard to comply? There are over 300 restaurants in this county-the ones creating this division aren't the only ones suffering, and have been given every resource available to adapt. If the other 300+ can limp along for a little while longer, so can they, and if they refuse, the rest of us shouldn't be punished.

I am a cancer survivor with a small child who lives with parents in their late 70s. I am also an essential worker that goes to work every day with a higher than average likelihood of exposure to the virus. The lengths I go to on a daily basis to keep myself, the public I assist, and my family safe are formidable, and exhausting. I find it disheartening and wonder if maybe I should walk away from my work I love to protect me and mine, because these people won't do their part. I'd imagine many essential workers and businesses striving to be responsible feel the same.

We are doing the right thing, for all of us. Please support us and protect us so its not in vain. Please vote yes on this ordinance and provide a tangible consequence for their actions, as their actions have a tangible consequence for the rest of us.

I am a county resident of 16 years. I'm an educator, an herbalist, a first responder, and a parent. I am deeply concerned about the division in our county over basic public health protocols. I am originally from New Jersey, 30 minutes from Manhattan, and I watched in horror for two months as dozens of my hometown and college friends shared news about getting sick, and family members dying. I know a number of people who were not killed by coronavirus, but whose organs have suffered severe damage- including young, healthy people.

Our numbers have been low, but since July began they've been increasing exponentially. We need to enforce masks, distancing, and outdoor dining and activities only. We need solidarity among business owners, and we need safer downtowns for our local citizens to be able to shop and support our businesses. Our household contains at-risk members, and we're not shopping at places that don't enforce policies.

I consider him a borderline personality. His wife kept him check prior to this but evidently she can no longer can do so.

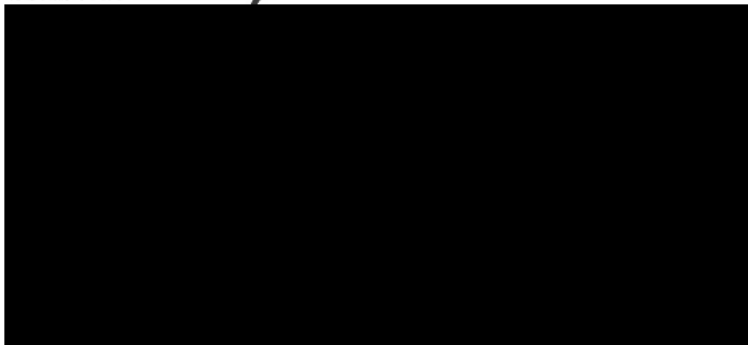

Hi, Ed,

I am a constituent of yours in District II. I have never had occasion to ask for your help, but your reputation is that you are open to hearing from us and always help your constituents to extent possible. I have always been impressed by that, because I think it demonstrates that you really care about the people you represent. Admirable!

I have a problem that I would like to share. I am 80 years old and as such, I am considered in the high risk category for Covid 19 infection. So for the most part, we shelter in place as much as possible. But, at times we need to go out for food and other necessities. My wife and I always wear a mask and socially distance. We wear masks to protect others in case we have contracted Covid 19, but not everyone is protecting us. When we go to grocery stores like SPD or Safeway, only about 2/3 of the customers wear masks. The store tells them they are required, but the employees have been told they cannot make customers do so.

More disturbingly, we stopped by Valentina's, one of our favorite places, to pick up burritos to take home. None of the employees wore masks and most customers did not. I asked Valentina why her employees did not wear masks. She said she had put up UV lights which took care of everything, and people have a constitutional right to not wear a mask. As much as I like Valentina as a person, her opinion is based on bad science and bad law. There is no constitutional right not to obey health directives, and the type of UV lights she installed do nothing. The kind she is talking about would make people blind and damage their skin. Attitudes like hers are a threat to our community and to my wife and me.

I also hear that when a representative of the County Health Department told the owners of Friar Tuck's that they had to comply or lose their license to sell food, she was treated despicably by the owners and was threatened by a group of anti-maskers that, among others threats, they would attack her at home. The police finally had to put her in a police car to protect from the unruly crowd. A friend of mine who is on the Nevada City Council witnessed the whole incident. Your employees need protection, too.

Please support this ordinance. I know you have constituents who are opposed, but this ordinance is based on good law and good science. We need to protect this community and not give into pressure from a more vocal but less representative few. By the way, all of the members of my HOA agree with us, even though most are conservatives. They want to be protected, too. Thank you very much for your consideration.

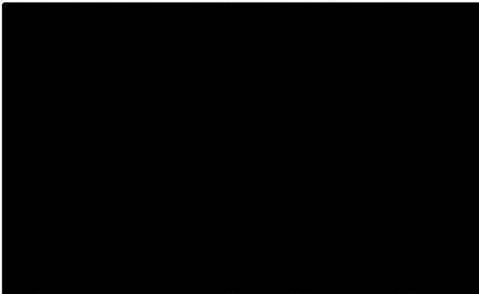

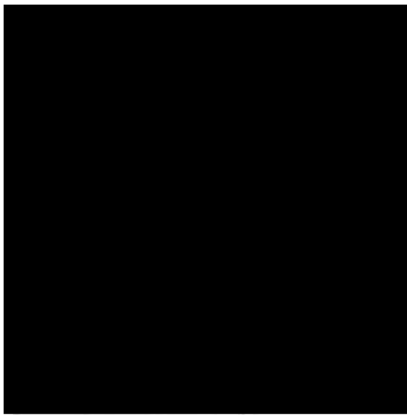

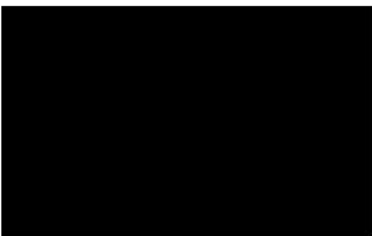
The Onyx Theatre has been closed since March 14, 2020 and we are not expecting to be able to safely re-open until some time in 2021. The longer Nevada County experiences active cases, the longer we will need to remain closed. It is my belief that businesses who are refusing to comply are putting businesses like the one I manage in a difficult position. It is not an easy thing to keep a business closed for the better part of a year, or more, but it is what we will have to do due to the size of our small screening rooms and intimate seating. We also employ fourteen Nevada County residents who will not likely be able to return to work until 2021.

Movie theaters will likely be one of the last business sectors to re-open and our county supports two independently and locally owned theaters (Onyx and Sierra Cinemas). We need the case numbers to be dropping and for everyone to be on the same page if we are ever going to get our movie theaters back. It would be very disappointing to have our county lose either of these businesses due to extended closures from COVID-19 in our community.

Dear Supervisor Hoek,

It is my understanding that the discussion you will be having with your fellow supervisors is that of public health and safety, which is not a partisan issue. It is also my understanding that it is not the intention, nor the responsibility, of this board to argue science. Yours is to create policy and to provide staff with effective enforcement tools, should they become necessary. The reality is simple— Nevada County has a responsibility to protect the health and safety of its citizens, no matter their political leaning. Providing policy and tools for staff to enforce public health regulation is not, nor should it become, a partisan issue.

During this time of worldwide pandemic it is particularly challenging to weigh the needs of our community. The economy is challenged and many of us are facing financial uncertainty. Until we're able to get a handle on the infection rate and stabilize our numbers the economy will continue to spiral. Our case count has increased 500% since partially reopening and we are 2-3 weeks behind in reporting of test results.

I'm quite proud of our community for their ability to collectively work toward safely reopening businesses. Nearly all of the over 300 dining establishments have done their part in helping return to a place where all businesses may reopen. They are following the guidelines established by the state of California. The very few who have chosen to defy the county health department are truly the exception and aren't representative of the majority. It is unfair for so many to comply, at great cost, while three choose non-compliance.

It is these exceptions to which I wish to address my comments. I ask that you support enhanced fines, as outlined in this proposed emergency ordinance, to be used as a tool by county staff if/when necessary.

Please vote in support of public health and in support of county staff.

In closing, I would like to thank you. I recognize the difficulty in holding a leadership role at this time and am appreciative of your willingness to do so. The divisiveness we are experiencing as a community and a country is disheartening. I know you weigh each consideration thoughtfully and do not allow partisanship to judge your decisions, for which I am grateful.

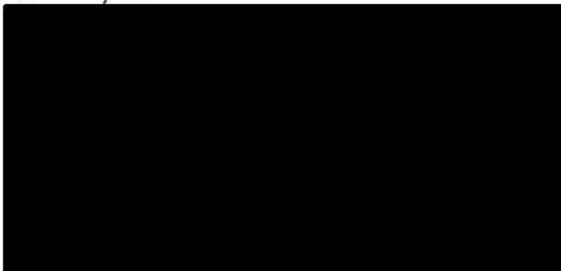
