SUBJECT: Resolution to award the contract for Electric Bus Charging Project

Nevada County Operations Center (NCOC) Phase-1, California Air Resources Board (CARB) Grant G20-NS-001, County Project No. 889830, for a Total Amount of \$294,250 to Lords Electric, Inc.,

RECOMMENDATION: Approve the attached Resolution.

<u>FUNDING</u>: This project at the Nevada County Operations Center (NCOC) is funded by Environmental Protection Agency (EPA) FY 2019/20 Targeted Airshed Grant (EPA-OAR-OAQPS-20-01) funds via sub-grantee contract No. G20-NS-001 with the California Air Resources Board (CARB), and by State Transit Assistance (STA) funds, and is included in the FY 2023/24 Transit Services budget. No budget amendment is necessary, and there is no impact to the General Fund.

BACKGROUND: On June 13, 2023 the Nevada County Board of Supervisors approved Resolution 23-269 authorizing the Purchasing Agent to solicit bids for Electric Bus Charging Project Nevada County Operations Center (NCOC) Phase-1. Two bids listed below were received and opened on July 13, 2023.

Bidder	Total Bid

1.	R&D Electric, Inc.	\$268,414.03
2.	Lords Electric, Inc.	\$267,500.00

Initial Engineer's Estimate \$240,000.00

R&D Electric Inc. rounded their bid amount to \$268,414, the figure shown here is the unrounded figure based on their bid item prices.

It is recommended that the contract be awarded to the low bidder, Lords Electric, Inc. at the bid price of \$267,500 plus a 10% contingency of \$26,750 for a total amount of \$294,250. Work is expected to begin in August 2023.
