
WHEREAS, said improvements were completed to the satisfaction of Nevada County Department of Public Works and certified by the Project Engineer on February 13, 2018; and

- 4. The Clerk of the Board is hereby authorized to release the warranty bond in an amount of \$76,237 to guarantee improvements one year and one day following the effective date of this resolution, provided no claim is made thereon.


