



# RESOLUTION No. 26-078

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

**RESOLUTION APPROVING AMENDMENT NO. 1 TO THE CONTRACT BETWEEN NEVADA COUNTY AND TRUEPOINT SOLUTIONS, LLC., FOR MAINTENANCE AND IMPROVEMENT OF THE ACCELA SOFTWARE PROGRAM (PEST5246), INCREASING THE NOT TO EXCEED AMOUNT TO \$140,000, EXTENDING THE CONTRACT TERM TO JUNE 30, 2027, AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE AMENDMENT, AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE FISCAL YEAR 2025/26 COMMUNITY DEVELOPMENT ADMINISTRATION BUDGET (4/5 AFFIRMATIVE VOTE REQUIRED)**

WHEREAS, Truepoint Solutions, LLC., and Nevada County entered into an “as needed professional services contract” for the Community Development Agency’s land-use software Accela for \$50,000 starting July 1, 2025, through June 30, 2026 (PEST5246 or SC00000512); and

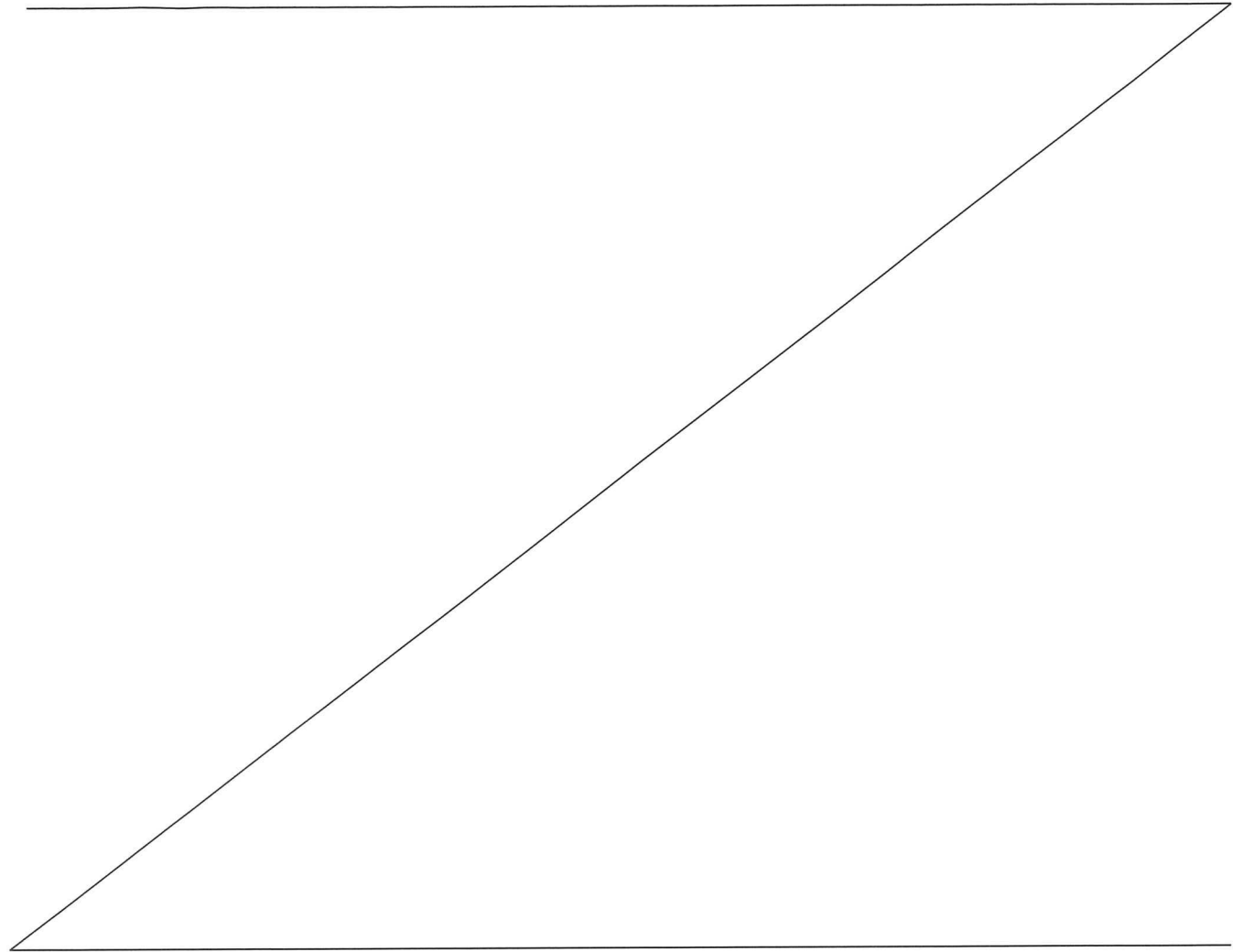
WHEREAS, due to unforeseen business changes because of the new enterprise-wide software, Workday, Truepoint supported Nevada County above and beyond to migrate to the new Workday platform as well as, tackling some outstanding projects that leveraged technology for high volume permits; and

WHEREAS, to provide the Community Development Agency with ongoing maintenance, as well as, continued software improvement within Accela before the contract is set to expire on June 30, 2026, both parties desire to increase the contract by \$90,000, to a new not-to-exceed amount of \$140,000, and extend the contract term by twelve months to June 30, 2027.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors of the County of Nevada, State of California:

1. Approve Amendment No. 1 to the As Needed Professional Services Contract with Truepoint Solutions, LLC.
2. Authorize the Chair of the Board of Supervisors to execute the contract amendment.
3. Direct the Auditor-Controller to amend the Fiscal Year 2025/26 budget as follows:

**AMENDMENT No. 1 TO PROFESSIONAL SERVICES  
CONTRACT WITH TRUEPOINT SOLUTIONS, LLC.  
(PEST5246 or SCON-00000512)**

**THIS AMENDMENT** is executed this 24 day of March, 2026 by and between Truepoint Solutions, LLC and the County of Nevada. Said Amendment amends the prior agreement between the parties entitled "As Needed Professional Services Contract" executed on the 2<sup>nd</sup> day of July 2025, and

**WHEREAS**, Truepoint Solutions, LLC was approved for an as needed professional services contract in the amount of \$50,000 from July 1, 2025, through June 30, 2026 (PEST5246 or SCON-00000512); and

**WHEREAS**, the parties desire to increase their agreement by \$90,000 for a new not-to-exceed value of \$140,000; and

**WHEREAS**, the parties furthermore desire to extend their agreement through June 30, 2027.

**NOW, THEREFORE**, the parties hereto agree as follows:

1. This amendment shall set a new not-to-exceed value of \$140,000.
2. This contract agreement is extended through June 30, 2027.
3. That in all other respects the Agreement of the parties shall remain in full force and effect except as amended herein.
