**SUBJECT:** Resolution approving Contract with HDR Construction Control Corporation Inc. for Construction Management and Inspection Services for the Hirschdale Road over Truckee River Bridge Replacement Project Federal No. BRLO 05917-092, County Project No. 224029 and Hirschdale Road at Hinton (UPRR) Overhead Rehabilitation Project Federal No. BRLO 05917-097, County Project No. 224030 for \$1,503,423.68 plus a 10% contingency of \$150,342.37 for a total amount not to exceed \$1,653,766.05 and authorizing the Chair of the Board of Supervisors to execute the Contract – District V

**RECOMMENDATION:** Approve the attached Resolution.

**FUNDING:** This project is funded by the Highway Bridge Program (HBP) funds and is included in the proposed FY 2024/25 Road Capital Improvement budget. Funding for this project has been programmed and authorized by Caltrans. Staff is awaiting the final E76 from the State approving the start of construction. A notice to proceed will not be issued without the E76 approval from Caltrans. No budget amendment is necessary, and there is no impact to the General Fund.

**BACKGROUND:** The Hirschdale Road over the Truckee River Bridge and the Hirschdale Road over the Union Pacific Railroad (UPRR) bridges have been deemed structurally deficient by the State of California. The State has agreed to fund construction/rehabilitation of these two structures however, the County does not have the staffing or expertise to provide construction oversight of these two projects.

On October 10, 2023, the County released a Request for Proposals (RFP) for professional engineering services for Construction Management and Inspection functions and received one proposal from HDR Construction Control Corporation Inc. (HDR). On November 3, 2023, the County readvertised and again received only one proposal from HDR. The RFP was for construction management and inspection for both the Truckee River Bridge Replacement Project and the Hinton Overcrossing Rehabilitation Project as the two projects were bid together due to their proximity to each other and for economy of scale.

The County performed an independent cost estimate and determined that the cost proposal from HDR was acceptable. HDR did meet the Disadvantaged Business Enterprise (DBE) goal of 20%.

It is recommended that the contract be awarded to HDR Construction Control Corporation Inc, at the price of \$1,503,423.68 plus a 10% contingency of \$150,342.37 for a total of \$ 1,653,766.05. Work is expected to begin in fall/winter of 2024.
