WHEREAS, said Contract was for the Laura Wilcox Memorial Building Accessibility Project in accordance with the plans and specifications; and

WHEREAS, said improvements were completed to the satisfaction of the Nevada County Chief Information Officer, the Grass Valley Building Department, and the Grass Valley Public Works Department on February 1, 2017, with contract costs totaling \$49,168.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Accepts the work as being completed.
2. Directs the Clerk of the Board to release the Bond for Labor and Materials in June, 2017 and the Bond of Faithful Performance in March, 2018.
3. Directs the Clerk of the Nevada County Board of Supervisors to record this notice in accordance with Civil Code Section 9208.

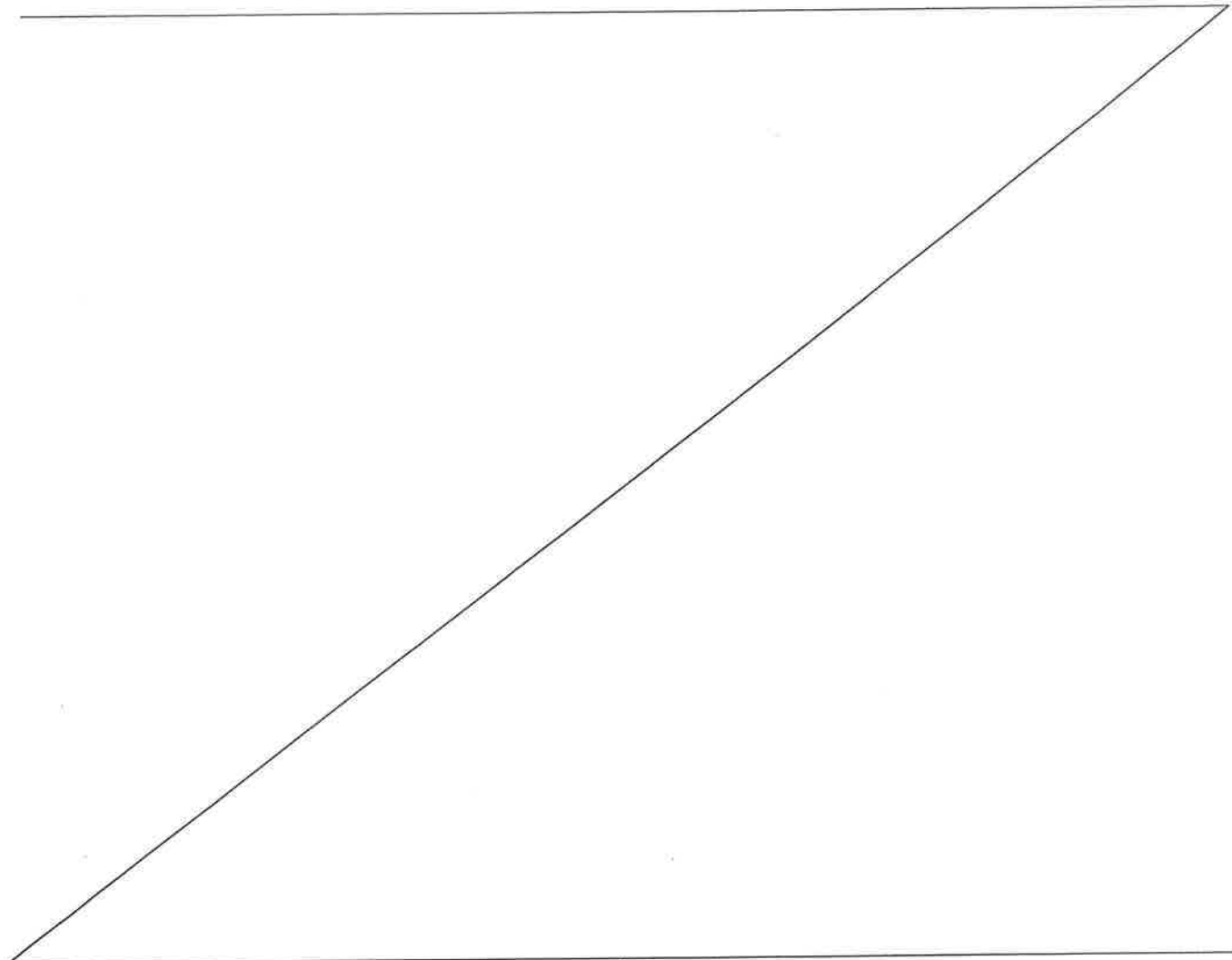
