RESOLUTION AUTHORIZING AMENDMENT NO. 1 TO THE AGREEMENT WITH SIERRA COUNTY FOR THE PROVISION OF BOOKING AND JAIL SERVICES FOR SIERRA COUNTY INMATES AT THE NEVADA COUNTY JAIL, TO EXTEND THE TERM BY ONE YEAR FROM JULY 1, 2023 TO JUNE 30, 2024 (RES. 20-454)

WHEREAS, the parties entered into an inmate housing Agreement to provide booking and jail services at the rate of \$136 per detainee per day for three fiscal years (Fiscal Years 2020/21. 2021/22 and 2022/23) with an option for up to two one-year contract extensions, per Resolution 20-454; and

WHEREAS, the parties wish to extend the agreement for the provision of booking and jail services by Nevada County to Sierra County from July 1, 2023 to June 30, 2024.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Chair of the Board of Supervisors, of the County of Nevada, be and is hereby authorized to execute, on behalf of the County of Nevada, Amendment No. 1 to the Agreement between Nevada County and Sierra County pertaining to booking and jail services, to extend the contract term to June 30, 2024.

AMENDMENT No 1 TO CONTRACT WITH County of Sierra

THIS AMENDMENT is executed this 5th day of July, 2023 by and between County of Sierra and COUNTY OF NEVADA. Said Amendment will amend Sierra County Agreement 2020-087, the prior agreement between the parties entitled Agreement for the Provision of Booking and Jail Services at the Jail Facilities operated by the Nevada County Sheriff's Office in Truckee and Nevada City executed on 27th day of October, 2020 by Resolution No. 20-454.

WHEREAS, the parties desire to amend their agreement to allow or provide for renewing the contract for an additional one year term; and

WHEREAS, the parties previously agreed to allow for two (2) additional one-year renewals based upon mutual written agreement upon the expiration of the original contract on June 30, 2023; and

NOW, THEREFORE, the parties hereto agree as follows:

- 1. This amendment shall extend the contract by 1 year for the term beginning July 1, 2023 and ending June 30, 2024, with a continued option to renew for one additional year.
- 2. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
