

ABOUT CMSP

Originally established in 1983, the County Medical Services Program (CMSP) provides health coverage for uninsured low-income adults, ages 21-64, in 35 rural and semi-rural California counties (shaded orange on map) and assists these counties in meeting their indigent care responsibilities under California law (WIC Section 17000).

The CMSP Governing Board, established in 1995 and composed of ten county officials and one ex-officio State representative, sets program eligibility requirements, determines the scope of covered healthcare benefits, and sets provider reimbursement rates for both CMSP benefit programs – CMSP and Connect to Care. State funding for CMSP ended in FY 2018-19. For more information, visit cmspcounties.org.
