



# **RESOLUTION No. 25-419**

## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

### **RESOLUTION APPROVING EXECUTION OF AN UPDATED AGREEMENT WITH THE DEPARTMENT OF HEALTH CARE SERVICES PERTAINING TO THE INTERGOVERNMENTAL TRANSFER AGREEMENT TO REFLECT THE INTEGRATED CONTRACT NUMBER 24-40138 FOR THE SERVICE PERIOD OF JULY 1, 2023, THROUGH DECEMBER 31, 2026 (RES 23-497)**

WHEREAS, on September 26, 2023 per Resolution 23-497, the Nevada County Board of Supervisors approved Contract 23-30116 between the County of Nevada and the Department of Health Care Services pertaining to the Intergovernmental Transfer (IGT) whereby Nevada County transfers the non-federal share of Medi-Cal payments and receives federal financial participation revenue for Drug Medi-Cal Organized Delivery System (DMC-ODS) services provided by the County, for the period July 1, 2023, through December 31, 2026; and

WHEREAS, on February 11, 2025, per Resolution 25-036 the Nevada County Board of supervisors approved Contract 24-40138 between the County of Nevada and the Department of Health Care Services to integrate the separate DMC-ODS 23-30116 and Specialty Mental Health contracts into one contract; and

WHEREAS, this Resolution updates the IGT agreement to reference the contract number from the integrated contract instead of the previous DMC-ODS only contract number; and

WHEREAS, the California Advancing and Innovating Medi-Cal (CalAIM) Act requires the Department of Health Care Services to implement Behavioral Health Payment Reform. As a component of Behavioral Health Payment Reform, DHCS is required to design and implement an IGT based payment methodology for DMC-ODS treatment services; and

WHEREAS, an IGT is a transfer of funds from a public agency to the Medicaid Single State Agency (SSA) that the SSA may expend as the nonfederal share in claiming Federal Financial Participation for Medicaid payments. In the context of CalAIM, Behavioral Health Payment Reform, an IGT is a transfer of funds from a county (the public agency) to DHCS (the Medicaid SSA) to be used as the county portion of the nonfederal share of payments to the county for Medi-Cal covered Behavioral Health Services (the "County Share"); and

WHEREAS, the parties desire to update the agreement to reference the current integrated contract number between County of Nevada and the Department of Health Care Services.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that this agreement be updated to reflect Contract No. 24-40138 by and between the County and the Department of Health Care Services, pertaining to the Intergovernmental Transfer, an agreement whereby Nevada County receives federal financial participation funds for Drug Medi-Cal ODS Services for the period of July 1, 2023 through December 31, 2026, is hereby approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Contract on behalf of the County of Nevada.
