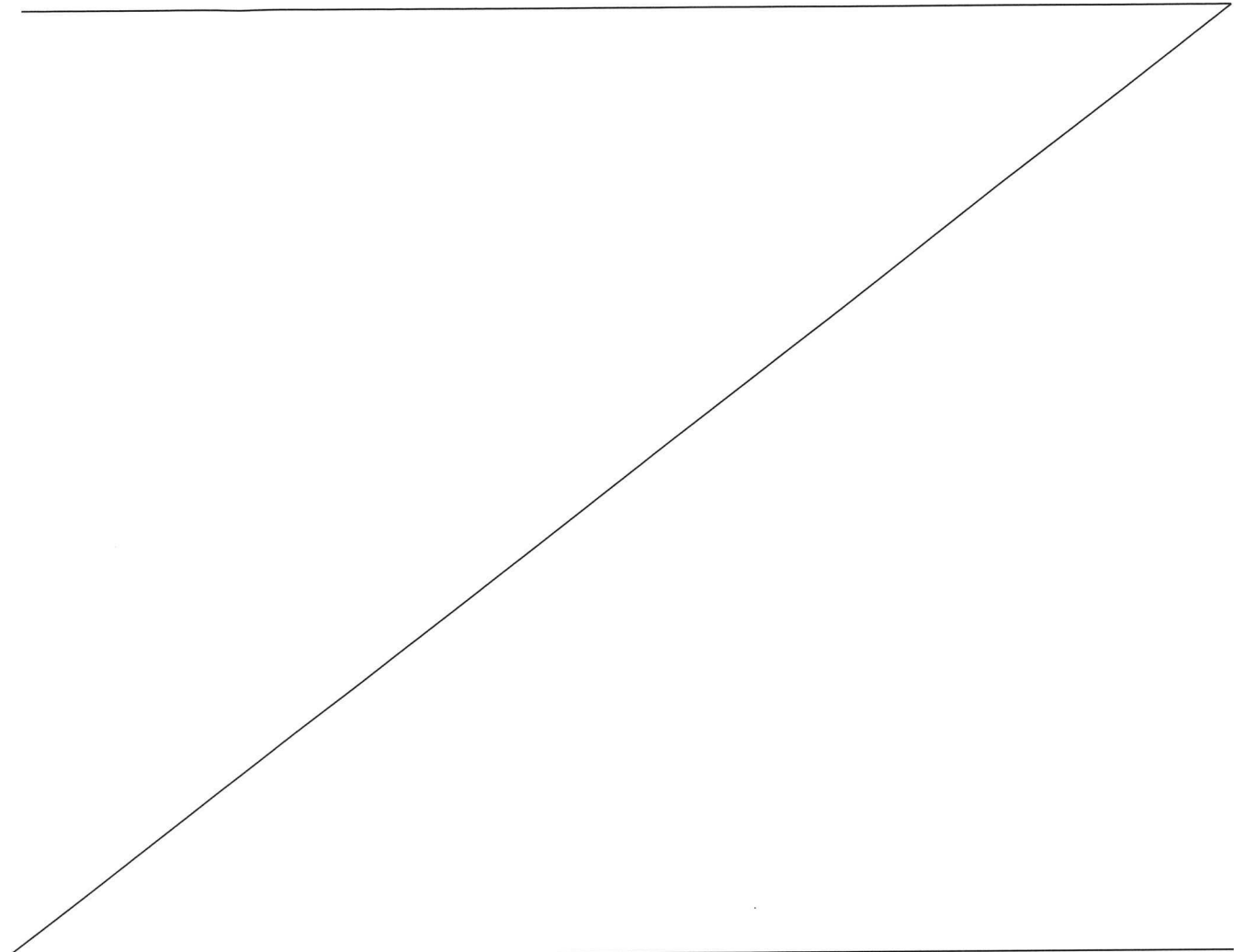
RESOLUTION APPROVING EXECUTION OF A RENEWAL CONTRACT WITH CRISIS INTERVENTION SERVICES, DBA SIERRA COMMUNITY HOUSE, FOR THE PROVISION OF LATINO OUTREACH SERVICES, FAMILY SUPPORT, PARENTING CLASSES, AND BEHAVIORAL HEALTH STIGMA REDUCTION IN THE EASTERN COUNTY REGION AS A COMPONENT OF THE COUNTY'S BEHAVIORAL HEALTH SERVICES ACT PREVENTION AND EARLY INTERVENTION PLAN IN THE MAXIMUM AMOUNT OF \$149,297, FOR THE CONTRACT TERM OF JULY 1, 2026, THROUGH JUNE 30, 2027

WHEREAS, Crisis Intervention Services (Contractor) provides Latino Outreach and Engagement Services, Family Support and Family Strengthening Programs in the Eastern County Region as a component of the County's Behavioral Health Services Act (BHSA); and

WHEREAS, these specialized services help to increase behavioral health access, engagement, linkage, and early intervention for Latinx community members in Nevada County, and to continue to provide responsive, accessible parenting education, support, and engagement opportunities to families, including under-served and high-need populations in Nevada County.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the contract by and between the County of Nevada and Crisis Intervention Services, DBA Sierra Community House, pertaining to the provision of Latino Outreach and Engagement Services, and other support services, as a component of the County's BHSA Plan for the contract term of July 1, 2026, through June 30, 2027, in the maximum amount of \$149,297, be and hereby is approved in substantially the form attached hereto, and the Chair of the Board of Supervisors be and is hereby authorized to execute the Contract on behalf of the County of Nevada. This contract is contingent upon the adoption of the Fiscal Year 2026/27 County budget. The contract begins on July 1, 2026.
