## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

### **RESOLUTION ADOPTING THE COUNTY OF NEVADA 2026 LEGISLATIVE PLATFORM**

WHEREAS, the Nevada County Board of Supervisors adopts its Annual Legislative Platform each year; and

WHEREAS, the County of Nevada has had opportunity to review and collaborate with regional, state, and national associations to identify major legislative priorities, actions, and positions for the upcoming year; and

WHEREAS, County Elected Officials and Senior Executives identified legislative positions and funding requests to advocate for the assurance of County financial stability and delivery of core services; and

WHEREAS, the County Executive Office encourages jurisdictional partnerships to identify areas of synergy for collaborative advocacy efforts for the benefit of the County and local community; and

WHEREAS, the Nevada County Board of Supervisors meets each year during their Board Workshop to develop their annual Priority Objectives for Nevada County; and

WHEREAS, the Board of Supervisors will hold their 2026 Board Workshop on January 28 through January 30; and

WHEREAS, County Elected Officials and Senior Executives will work to identify legislative positions and priority funding requests to support the inclusion of the Board's 2026 Priority Objectives in the 2026 Legislative Platform; and

WHEREAS, the 2026 Legislative Platform incorporates legislative positions and funding requests to help guide advocacy efforts and provide the County with increased flexibility to quickly respond and proactively advocate for positions that promote the County's priorities and to address fiscal, programmatic and/or unfunded mandated threats to the County's core services and values; and

WHEREAS, the Board of Supervisors authorize staff to make administrative updates to the 2026 Legislative Platform to reflect priority legislative positions, funding requests, and 2026 Priority Objectives identified at the Board Workshop.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors adopts the attached 2026 Legislative Platform for guidance and use by all County staff and departments and legislative advocacy activity.

BE IT FURTHER RESOLVED that the County Executive Officer is directed to use the Legislative Platform for the implementation of the 2026/27 Fiscal Year Budget, the management of County operations, programs and services, the promotion of the Priority Objectives; and to quickly respond and proactively advocate to address fiscal, programmatic, or unfunded mandated threats to the County's core services and values.

BE IT FURTHER RESOLVED that the County Executive Officer, in coordination with the Board Chair, is authorized to make administrative updates and updates consistent with the Board of Supervisors' adopted Priority Objectives during the course of 2026, subject to Board consideration as part of the adoption of the County of Nevada 2027 Legislative Platform.

BE IT FURTHER RESOLVED that the Chair of the Board of Supervisors is authorized to conduct legislative advocacy, including signing and submitting Letters of Advocacy, on behalf of the Board of Supervisors in accordance with the 2026 Legislative Platform that includes the following:

1. For Letters of Advocacy on behalf of the Board of Supervisors, the County Executive Officer or respective designee(s) shall determine and provide recommendations to the Chair of the Board on positions captured in the 2026 Legislative Platform for the Chair's consideration, approval, and signature.
2. The Vice Chair shall be provided notice on advocacy recommendations.
3. All Board members shall be copied on all approved and submitted Letters of Advocacy.
4. Any Letter of Advocacy regarding an issue that is not captured in the 2026 Legislative Platform or determined to be controversial must be approved by the Board of Supervisors.

# Executive Summary

## Overview

The Nevada County Legislative Platform (Platform) provides a framework to support legislative and regulatory advocacy which seeks to ensure sustainable delivery of core public services, advance top priority objectives as adopted by the Board of Supervisors, as well as solicit funding for infrastructure needs, capital projects, and other services and programs that support and promote the well-being of Nevada County residents and communities.

The Platform includes key legislative positions for the year ahead, legislative contact information, a non-exhaustive list of important projects, and policy positions organized into five policy areas:

1. Administration of Justice (AOJ)
2. Agriculture, Environment, and Natural Resources (AENR)
3. Government Finance and Administration (GFA)
4. Health and Human Services (HHS)
5. Housing, Land Use, and Transportation (HLT)

## Development Process

The County Executive Office leads the annual effort to identify and assess priorities, funding requests, and initiatives by engaging the senior executive team, the County's contracted and membership-based legislative advocates, and the Board of Supervisors. Input is also solicited from County departments to ensure alignment with program-specific issues including those elevated in existing County plans such as the Capital Facilities Plan, Recreation and Resiliency Master Plan, and Economic Development Action Plan.

Throughout the development process, stakeholders and partners convene to explore opportunities for regional coordination on the County's most pressing issues, strengthening our collective advocacy at the State and Federal levels. Participating stakeholders include the City of Grass Valley, City of Nevada City, Town of Truckee, school districts, special districts, and other key community partners. Once finalized, the Platform is formally adopted by the Board of Supervisors each year.

## Use

The Legislative Platform serves as a guiding document throughout the year for the Board of Supervisors, County Executive Office, and senior executive team to evaluate legislative issues as they emerge and determine whether advocacy on a particular matter aligns with the County's adopted positions. The Platform is also shared with the County's contracted legislative advocacy firms: Shaw Yoder Antwih Schmelzer & Lange, Inc. and Paragon Government Relations, Inc. The Platform is publicly available on the County's website to promote transparency and engagement.

To further highlight alignment with the Board of Supervisors' priorities, policy positions which directly support a Board Objective are identified with a corresponding icon.

## Priority Objectives

The Board's priority objectives will be adopted in February 2026, at which time this document will be updated to reflect any changes in priorities. The 2025 objectives included fiscal stability and core services, emergency preparedness, economic development, broadband, climate resilience, housing, homelessness, and recreation.

## **2026 Key Legislative Positions**

The positions below highlight the County's top legislative priorities, aligned with the Board's adopted objectives and informed by pending or emerging legislative opportunities and threats that have significant impacts on County operations and services.

### **Broadband**

Advocate for legislation and rulemaking that removes bureaucratic barriers to implementing programs and grant funding that supports critical broadband projects in rural areas. Support efforts and funding to advance the availability, affordability, digital equity, and reliability of broadband service.

### **Cannabis**

Support efforts to improve alignment between federal law and state-regulated cannabis programs. Oppose legislation that reduces local jurisdictional authority over cannabis activity.

### **Carrier of Last Resort**

Oppose efforts which would allow a Carrier of Last Resort telecommunications provider to abandon those responsibilities to ensure residents have continued access to reliable and affordable basic telephone service in case of emergencies.

### **Farm Bill Reauthorization**

Advocate for Farm Bill Reauthorization and the appropriation of federal funds and programs that support and promote rural community issues which may include nutrition, workforce housing, public lands management, wildfire protection, preparedness, forest resiliency, pest detection, and surveillance.

### **Federal Funding**

Oppose legislation that results in budget cuts to County projects or core services or reductions in programs that would adversely impact California counties.

### **FEMA Reform**

Support FEMA reforms that ensure transparent, timely provision of funds for disaster reimbursement, streamlining of environmental and historic preservation reviews, and review and approval of administrative actions that allow grant-funded projects to be implemented in a timely manner.

### **Fire and Special Districts**

Support legislation that provides the necessary funding mechanism changes for both fire and special districts that results in increased funding to support operations.

### **Forest Management and Green Waste Removal**

Advocate for ongoing sustainable funding for wildfire mitigation projects and programs, including direct funding allocations to the Office of Emergency Services and community partners.

### **Health and Human Services Programs**

Advocate for ongoing, sustainable state and federal funding for health and human services programs and oppose efforts that pass costs associated with the impacts of federal funding and programmatic cuts onto counties or local healthcare providers.

### **Homelessness**

Support policy initiatives and legislation that map out and address comprehensive systems to address homelessness, provide flexible funding for ongoing costs associated with providing services to unhoused residents and those at risk of homelessness, and promote the development of housing.



**Housing**

Support legislation to streamline development while maintaining local control, increase funding for affordable and workforce housing development, and remove barriers to access. This may include increasing state income limits to keep pace with increasing wages and inflation over time to allow for affordable housing and service eligibility.

**Medi-Cal Healthcare Services**

Advocate for rulemaking to ensure efficient and effective delivery of Medi-Cal services, including specialty mental health services and substance use disorder services, and for measures that protect the financial viability of rural hospitals. Oppose any state actions that transfer the financial burden of federal Medicaid cuts onto counties.

**Public Land Resources and Management**

Advocate for additional resources to address increased visitation to public lands, including resources to support operations and maintenance needs, administrative staff to support planning and compliance, and increased law enforcement staffing from State Parks, USFS, BLM, and USACE.

**Realignment**

Oppose legislation and regulation that changes state Realignment agreements including stripping local authority and transferring financial liability to counties.

**Recreation Infrastructure**

Advocate for funding to support recreation infrastructure including facilities, wayfinding, and parking, as well as ongoing resources and staffing for maintenance to mitigate public safety risks associated with peak period visitation and tourism.

**Residential and Commercial Wildfire Insurance**

Advocate for legislation, regulatory actions, or other innovations that strengthen consumer protections, improve access to affordable residential and commercial wildfire insurance, require transparent and consistent risk modeling, expand risk mitigation incentives, and continue to study and identify potential solutions to address the availability and affordability of wildfire insurance.

**Rural County Exemptions**

Support legislation that provides the necessary funding, regulatory flexibility, and promotes public-private coordination for local rural communities to fund, develop and maintain infrastructure and programs. Support the inclusion of rural exemptions in legislation and regulation that recognize unique rural characteristics, promote resource equity, and offset challenges associated with economies of scale between rural, suburban, and urban counties.

**State Funding**

Oppose legislation that results in budget cuts to County programs, projects, or core services. Oppose any state mandates that shift financial responsibilities to counties to backfill federal funding cuts, including unfunded mandates that arise from the intersection of federal changes and current state law.

**Sustainable Funding and Unfunded Mandates**

Advocate for sustainable resources for ongoing programs and services that include transparent funding mechanisms and oppose efforts to establish county mandates or ongoing programs and services without ongoing funding.

## 2026 Projects List

The list below highlights a dynamic group of priority projects that Nevada County aims to advance through ongoing planning, advocacy, and funding efforts. While not a comprehensive inventory of all County efforts, the list represents some of the community's most pressing needs and strategic opportunities.

#### **Alder Creek Workforce Housing**

Collaborative workforce housing project between the Tahoe Truckee Unified School District (TTUSD) and Truckee Tahoe Workforce Housing Agency aimed at easing the housing burden for TTUSD employees and other local workers. The project can be phased and would include up to 72 units in a mix of townhomes and apartments.



#### **CAL FIRE Emergency Command Center/911 Dispatch Facility Expansion**

This project would increase the capacity of the center that serves as the 911 dispatch for CAL FIRE related calls within Nevada County. The current facility houses the 911 dispatch for 31 agencies including all EMS and fire across the county. 911 is facing an increased call volume up from approx. 6,000 per year in 1990 to 49,000 currently. To maintain this critical safety element, additional space and capacity will need to increase to continue serving at the same level.



#### **Capacity Improvements to Hwy 20 @ Pleasant Valley Road**

This infrastructure project will address existing operational deficiencies and develop a preferred alternative for construction that will improve traffic flow, reduce congestion, and enhance safety at this critical regional intersection.



#### **Eastern County Snow Removal and Road Maintenance Equipment**

The County has been renting various locations in eastern Nevada County to house snow removal and road maintenance equipment and needs a permanent facility which includes electricity to support charging for EVs to ensure compliance with potential mandated clean fleet requirements in the future. Additionally, space is needed to allow a resting area for road maintenance crews. This project will support emergency preparedness efforts by allowing transportation readiness.



#### **Edwards Bridge Project**

This historic bridge over the South Yuba River, at a popular recreation destination commonly referred to as "Edwards Crossing," was built in 1904. The project would provide a safe permanent crossing over the river on North Bloomfield Road. The County proposes to construct a new two-lane bridge at one of two upstream locations, either 60' or 1,000' upstream, with the 1,000' option ("Alternative 2") being the preferred option, with its Environmental Impact Review estimated to be completed in mid-2026. The existing bridge will be left in place for pedestrian and historical access.



#### **Forest Management and Wildfire Mitigation**

As part of the ongoing process of wildfire mitigation projects and programs, this initiative will address priority wildfire resilience efforts across the county.

- **The Community Wildfire Ignition Mitigation Project:** Remove 500 acres of hazardous vegetation within CWPP Project Priority areas and provide roadside chipping to approximately 2,000



residents, 45% of which are in a Low-Income Community, and 92% of which live in a Very High or High FHSZ, to support defensible space in wildfire-threatened communities and mitigate a common wildfire ignition source through a Burn Pile Education Program.

- **Deer Creek Canyon Fuel Mitigation:** In collaboration, with City of Nevada City, non-profits, the Nisenan Tribe, Firewise Communities, Nevada Irrigation District, and others, advance multijurisdictional forest health, fuel mitigation, and watershed protection projects in the Deer Creek Canyon that protect critical infrastructure and natural resources.
- **Greater Banner Mountain Ingress Egress Project:** Treat 795 acres along critical ingress and egress routes in the Greater Banner Mountain area and Scott's Flat Reservoir, including fuel reduction along County-maintained roads, private roads, and private property. The project will provide 20 to 300 feet of roadside fuel reduction using a variety of treatment methods; with the goal of reducing wildfire risk and providing safer evacuation routes.
- **South Yuba Canyon Fuel Mitigation:** In collaboration, with CAL FIRE, Yuba Watershed Institute, Bureau of Land Management, State Parks, USFS Tahoe National Forest, Firewise Communities, and others, advance multijurisdictional forest health, fuel mitigation, and watershed protection projects in the South Yuba Canyon that protect critical infrastructure and natural resources.
- **Washington Wildfire Defense Project:** Create critical ingress/egress corridors and wildfire defense zones on USFS land surrounding the disadvantaged community of Washington, CA. This project proposes to treat approximately 172 acres of USFS land. Treatments will include manual cutting, piling, covering of piles, and installation of fire control lines. Consistent with Tahoe National Forest practices, USFS Fuels Crews will conduct pile burning in 2027–28.
- **You Bet Wildfire Defense by Design Project:** Pilot the Wildfire Ready Roads prioritization tool and improve regional capacity for implementation of CWPP-based projects using standardized metrics. Focused on the 12,655-acre You Bet Firewise USA® Community (YBFWC) in Grass Valley, CA, this project treats private parcels as a unified landscape, incorporating landowner input while aligning with Nevada County's CWPP goals and regional treatment standards.
- **Yuba Forest Resilience Project:** Execute a new GNA with USFS Tahoe National Forest that would allow County of Nevada to manage projects and administer timber sales on behalf of the forest and reinvest the revenue into Wildland-Urban-Interface (WUI) projects of community significance.



#### **Health and Human Services Campus**

Health and Human Service Agency staff and operations are spread out between three different Western County locations. Efficiencies would be gained, and customer service improved if all operations were co-located.



#### **HealthSpan**

This communitywide wellness initiative led by the Sierra Nevada Memorial Hospital Foundation aims to enhance community health outcomes, reduce the prevalence of chronic diseases in the region, and alleviate the burden on the region's already strained healthcare system. By identifying and elevating effective health and wellness programs, HealthSpan helps ensure that proven strategies receive the attention and resources they need to make a broader impact.



#### **Helipad Upgrades at Nevada County Airport**

Rehabilitate and expand the helipad at the Nevada County Airport to allow for multiple CAL FIRE aircraft uses, including the S-2 tankers and the S-71i Fire Hawk helicopter, which will expand regional wildland firefighting capabilities. Specifically, a "Pen and Ink" change is required from the

FAA to the Nevada County Airport Layout Plan to move the project forward.



#### **Highway 49 Corridor Improvements**

This multi-modal 2.5-mile project will provide significant safety and traffic flow improvements to this two-lane segment of SR 49 between McKnight Way and La Barr Meadows Road. Among other things, it will widen this segment to a four-lane conventional access control highway, install a continuous median barrier, remove numerous ingress/egresses to the highway, construct a frontage road system, install eight-foot shoulders with rumble strips, provide animal undercrossing/fencing, and more.



#### **Independence Trail Reconstruction**

In August 2020, the Jones Fire destroyed wooden flumes that served as bridges to transport visitors on Independence Trail West, including those using wheelchairs, over deep canyons and ravines. Bear Yuba Land Trust, the owner of this section of the Independence Trail, is seeking funding or to transfer ownership of this land to State Parks, to rebuild this iconic ADA-accessible recreational amenity.



#### **Mobile Health Programs**

Advocate for sustainable funding and opportunities to develop additional mobile health programs that further reach rural underserved communities with primary care and preventative health services.



#### **Nevada County Animal Shelter and Emergency Evacuation Site**

The existing facility is over 30 years old and is too small to meet current community needs, requiring reliance on foster homes. The facility lacks adequate parking and is not appropriately accessible. The current shelter was designed for outdated sheltering practices of capture, confine, and euthanize, and does not offer a modern adoption-centric layout. The County relies on the animal shelter, as well as the Nevada County Fairgrounds, to house hundreds of animals during emergency wildfire evacuations. The current animal shelter's ability to meet this need is inadequate.



#### **Nevada County Courthouse**

Coordinate with the City of Nevada City and the State of California to support alternative uses for the courthouse as well as manage and minimize any disruptions that arise from its relocation.



#### **North San Juan Fire Suppression Project**

This project involves construction of a 330,000-gallon water storage tank, approximately 4,200 feet of water mains, and 10 fire hydrants, in the commercial core of North San Juan to provide fire-water storage and distribution for commercial and residential uses in the area. Completion of the project is intended to remove a barrier for economic development and provide a reliable, robust means of fire-water supply in North San Juan.



#### **Penn Valley Community Center**

The Penn Valley community identified a community center as a top priority in the Penn Valley Area Plan, completed in 2020. On land owned by the Penn Valley Community Foundation, the community center would provide much needed meeting rooms, a commercial kitchen, event, and outdoor activity space.





### **Pines to Mines**

Nevada County, in collaboration with Tahoe National Forest and local nonprofit partners, has prioritized the creation of the Pines to Mines Trail—a 72-mile route linking Nevada City to Truckee. This trail is being completed in sections and will connect communities, highlight Nevada County's most spectacular natural landscapes, and stimulate sustainable economic growth through outdoor recreation and tourism.



### **Psychiatric Health Facility and Mental Health Rehabilitation Center**

This project includes building a small and secure, inpatient mental health facility that will provide two essential levels of care: Psychiatric Health Facility (PHF) which is designed for short-term treatment and Mental Health Rehabilitation Center (MHRC) which offers longer-term treatment. This new center will ensure that those in need can receive timely, high-quality care locally.



### **Regional Biomass Opportunities**

Leverage the multi-county (Nevada/Placer/El Dorado) Biofuel Development Opportunity Zone Rating Report to foster regional coordination of efforts that advance the development of bio-based business development including community green waste events, bioenergy facilities, local sawmills, and biochar production.



### **Right-of-Way Identification Projects on County Roadways**

This project will support surveying needed for reporting to FEMA, facilitating brush clearing as part of the fire prevention activities, and the establishment of evacuation routes.



### **Road Infrastructure Improvements that Strengthen Emergency Ingress/Egress**

Funding is needed for design and construction of road improvements on various locations throughout the county to strengthen emergency ingress/egress.



### **Rough and Ready Hwy/Ridge Road/Adam Ave Intersection Improvements**

Realign two three-legged, angled intersections into one four-legged intersection. The proposed improvements would convert the side street stop controls at both existing intersections into a single roundabout. In conjunction with the roundabout, design considerations will include pedestrian and bicycle facility improvements.



### **Rural Community Fire Station Improvements**

Projects to improve fire stations in North San Juan and the Town of Washington to enhance emergency preparedness and provide essential community services in these isolated communities. Funding is needed for plan readiness and construction.



### **Safe Recreation Access to Rivers**

As part of ongoing bridge replacement projects, this initiative will expand, modernize, and improve public access to river recreation areas while addressing critical safety and infrastructure needs. Five heavily used bridge access points have been identified as priority areas due to high recreational traffic, limited parking, insufficient amenities, and unsafe roadway conditions.

- **Dog Bar:** Improve river access, create off-roadway parking, enhance signage, and add bike and pedestrian lanes.

- **Hirschdale Truckee River:** Conduct location study, planning, design, and construction of a formal parking lot, river access points, restrooms, trash facilities, and related amenities.
- **Edwards Crossing:** Construct and improve parking areas with direct trail and river access; update signage; and incorporate clear no-parking/fire lane zones and advance warning signage.
- **Purdon Crossing:** Create designated, striped parking in the existing area, and add restrooms, trash facilities, and signage.
- **South Yuba River at Highway 49:** Broaden roadways on both sides of the bridge to provide safe off-roadway parking and signage and construct a vault toilet and wayfinding facilities at the Highway 49 crossing of Independence Trail.



#### **Scotts Flat Dam Spillway**

Funding is necessary for the construction of the mandatory replacement of the Scotts Flat Dam which is owned, operated, and maintained by Nevada Irrigation District. The dam is vital to local communities, which rely on it for water delivery, recreation opportunities, wildlife habitat, and as an economic driver. In addition, the Scotts Flat hydropower plant generates 875 kilowatts of electricity. Design work will continue in 2026, and construction is estimated to begin in 2027.



#### **Stagecoach Veterans Housing Project**

This includes a purchase and remodel of an existing motel into permanent housing prioritized for homeless veterans. Funding is needed to supplement project costs that exceed anticipated receipt of grant award funds.



#### **Truckee Library**

Advocate for funding to supplement public dollars to construct a spacious 21st century library to serve the Truckee/ Martis Valley Region and Placer County residents in partnership with community stakeholders.



#### **Truckee Navigation Center**

Advocate for funding to develop a Navigation Center in Truckee, including acquisition or new construction. Currently pursuing a lease, which if successful, will be ready for small-scale tenant improvements and subsequent occupancy.



#### **USDA Inspected Animal Harvest Facility**

Advocate for funding for a USDA-inspected and community-run animal harvesting facility owned by the Nevada Joint Union High School District, located at the school ranch that supports local farmers and ranchers while providing student internship and CTE opportunities. The facility will complete the farm-to-fork cycle, strengthening student learning and the local agricultural economy.

### **Climate Resilience**

Safeguard Nevada County's economic durability, environmental integrity, and public health and safety by preparing for, adapting to, and mitigating changing climate conditions in a way that reflects our rural quality of life.



### **Housing**

Coordinate with local jurisdictions, developers, and other partners to facilitate development of, and access to, affordable and workforce housing.
