**District 1, Heidi Hall**

District 1 Supervisor Heidi Hall began her first term in January of 2017. She served as the chair of the board in 2020, and was re-elected to serve a second term beginning January 2021.

Heidi Hall enjoyed spending summers and holidays in Nevada County as she grew up in the San Francisco Bay Area in a family of educators. In 2005, she moved to the family cabin to raise her two boys and enjoy the natural beauty and community Nevada County offers year round. Building rural social and economic resiliency through protecting forest health, expanding broadband, promoting outdoor recreation and maintaining our local quality of life has been her focus for over a decade. She enjoys serving on local, regional and statewide committees and takes pride in being both collaborative and solutions driven. She brings both professional expertise and a life-long love of the Sierra Nevada Foothills to everything she does.

Her leadership is informed by 25 years of experience as an environmental professional with the federal and state governments, including the U.S. Environmental Protection Agency (EPA), where she managed both budgets and staff and as program manager at Resources Conservation Board, (SWRCB) and the Department of Water Resources (DWR). This unique experience in water and resource management lead to working on initiatives in four states and with 122 tribes. Her professional experience in this sector is both a point of pride and a reflection of the collaborative problem solving she brings to complicated issues.

In addition to her work as District 1 Supervisor, she currently serves as a program manager with the California State Department of Water Resources. She works with government leaders at all levels and expertise, from both the scientific and policy communities, to find solutions to pressing policy issues.

As a community activist, Heidi has served on several non-profit Boards, volunteered as a Court Appointed Special Advocate for Children (CASA), and even participated in "Dancing with our Stars," a fundraiser for The Center for the Arts. Heidi ran for Congress in District 1 in 2014, where she gained a broad base of support for her advocacy regarding local rural issues, including better solutions to homelessness, meeting unmet mental health care needs, fire safety (and other public safety measures) and the need for better internet connectivity for a stable and sustainable economy. She has served as a delegate for and is currently an Executive Board member to the California State Democratic Party.

Heidi received her B.A. from Pomona College in International Relations and holds two M.A.s in International Relations and Public Policy from Columbia University and Rutgers University, respectively.

Like many in Nevada County, family is a top priority. She gains strength and inspiration from her husband, children, in-laws, and her beautiful grandchild. In her free time, she can be found hiking our trails, exploring the Yuba River with her dogs, or taking in the arts and culture of our vibrant downtowns.

**District 2, Ed Scofield, Vice Chair**

Served as Chair of the Board: 2011 and 2015

Ed Scofield was born in Grass Valley, California at the old Grass Valley Hospital that is now a parking lot on South Auburn Street. He graduated from Nevada Union High School in 1962 and from Sierra College in 1965.

Ed has always been active in Nevada County community organizations and was previously president of:

- Grass Valley Jaycees
- Grass Valley Little League
- the Grass Valley/Nevada County Chamber of Commerce
- the Rotary Club of Grass Valley

Ed was elected to the Grass Valley City Council in 1975 and served until 1982 in that capacity. He is currently President of the Rotary Club of Grass Valley South.

In November of 1982, Ed was appointed as the Secretary / Manager of the 17th District Agricultural Association; better known as the Nevada County Fair. He served as the Fairgrounds CEO until his retirement in 2008. During his tenure with the Fair, he was active with the Western Fairs Association where he served as President in 1996, and was inducted into the Western Fairs Hall of Fame in 2004. Ed continues his dedication to the fairgrounds by serving as a member of the Nevada County Fairgrounds Foundation, Inc. The Foundation is a 501 (c)(3) with a mission of fund raising for improvements to the fairgrounds, especially in those areas serving the youth of Nevada County.

In 2008, Ed was elected to serve a four-year term from 2009-2012 as District II Supervisor. He served as Vice-Chair in 2010 and Chair in 2011. In 2012, Ed was elected to another four-year term and served as Board Chair in 2015. In 2017, he was elected for another four-year term through 2020 and was selected to serve as the Vice Chair. In 2021, he started his current four-year term.

His current assignments include serving on the Nevada County Transportation Commission and Transit Services Commission, the National Association of Counties (NACo), the Nevada County Airport Land Use Commission (NCALUC), and the Northern Sierra Air Quality Management District Board (NSAQMDB). Moreover, he also serves as a Board member of the Nevada County Economic Resource Council (ERC), Workforce Development Board NoRTEC, and serves as the County representative on the Board of the California State Association of Counties (CSAC) and as the Treasurer on its Executive Committee.

Ed also serves on the Board of Directors of Sierra Nevada Children's Services and was recently elected to the Vestry of the Emmanuel Episcopal Church.

Ed has been married to Carol for 30 years. They have three children, Wendy, Ed (the 4th) and Nicole; in addition to Brandyn, who joined the family as a "Little Brother" in 1994. They have six grandchildren and one great grandchild.

From 1997-2001, Dan served on the Grass Valley Planning Commission. In 2001 he was elected to the Nevada Joint High School District Board of Trustees and served as its President from 2003-2005. Dan has also served as President of the Sierra College Foundation, Nevada County Campus and on the Board of Directors for the Grass Valley/Nevada County Chamber of Commerce and the Board of Directors for the Nevada County Country Club.

In 2014, Dan was elected to the Board of Supervisors, and served as vice chair in 2015 and chair in 2016 and 2021. **District 5, Hardy Bullock**

Hardy Bullock, supervisor for Nevada County's fifth district is a lifelong resident of Nevada County, and a graduate of Nevada Union High School and the University of Nevada Reno. Hardy holds accreditation from the American Association of Airport Executives and serves as a regional mentor to candidates in the executive accreditation program.

Hardy currently consults in the aviation/unmanned aerial systems and aeronautical planning fields for clients nationwide. Previously, he served as the Director of Aviation and Community Services for the Truckee Tahoe Airport District. He was tasked with the safety, security, and efficiency of this regional non-hub airport. Hardy has spent the last fifteen years finding creative solutions to problems facing commercial aviation. He is a multi-engine instrument-rated pilot with nearly 2,000 hours of flight time in various types of fixed-wing aircraft, gliders and jets.

He has served with distinction on the National Business Aircraft Association as the Airports Safety Team Leader. Hardy is a frequent speaker at national events related to aviation emissions, environmental impact reduction and aeronautical safety. Hardy has worked to promote the non-profit, community service sector by creating a non-profit warehouse space that provides food and family services, as well as organic food options, for the Truckee North Tahoe Region.
