### Summary of Request

Staff requests approval of payments for the Beverage Container Recycling City/County Payment Program (Program) for fiscal year 2015–16. Staff received 430 eligible applications requesting \$9,536,188 for this payment program. The funding available for fiscal year 2015–16 is \$10,500,000.

## Funding

The Beverage Container Recycling City/County Payment Program is a continuous appropriation from the California Beverage Container Recycling Fund in the amount of \$10,500,000 per fiscal year.

The amount remaining reflects the total of all eligible funds from jurisdictions that did not apply, \$885,221, and the remaining eligible amount from the City of Santa Ana who was eligible to receive \$84,591 but requested \$6,000 leaving \$78,591 of their award to be returned to the fund.

## Background and Findings

### Statutory Authority

Pursuant to Public Resources Code Section 14581(a)(3)(A) of the California Beverage Container Recycling and Litter Reduction Act, CalRecycle is authorized to expend \$10,500,000 annually for payments to cities and counties for beverage container recycling and litter clean-up activities. Payments are calculated on a per capita basis, with a minimum payment of \$5,000 to cities and \$10,000 to counties.

### Program Background

The Program provides annual funding to California cities and counties for beverage container recycling projects that assist in achieving an 80 percent recycling rate for the state. Incorporated areas of a city, city and county, or the unincorporated area of a county (as reported by the California Department of Finance's annual population report (*E-1 Cities, Counties, and the State Population Estimates with Annual Percent Change*)) are eligible to receive funding. Jurisdictions receive funding on a per capita basis, or a minimum of \$5,000 for cities and \$10,000 for counties, whichever is greater. All funds shall be available for expenditure until June 29, 2018, and are subject to reporting requirements.

### Criteria and Process

Eligibility criteria, evaluation process, program management, and proposed changes were discussed at the February 16, 2016, CalRecycle Public Meeting and subsequently approved by the Deputy Director and revised on June 24, 2016. The Notice of Funds Available was posted on CalRecycle's website and emailed to all jurisdictions on March 1, 2016. The deadline to submit the Funding Request was June 1, 2016.

There are 539 jurisdictions in all. Of these, CalRecycle received 417 individual Funding Requests and 13 regional Funding Requests, which included 34 jurisdictions. The remaining 75 jurisdictions identified in Table 2 did not submit a Funding Request and those funds will revert back to the California Beverage Container Recycling Fund. All funds shall be available for expenditure until June 29, 2018, and are subject to reporting requirements.
