


TRUTH ACT

- TRANSPARENT REVIEW OF UNJUST TRANSFERS AND HOLDS (T.R.U.T.H.)
- APPROVED BY GOVERNOR BROWN ON SEPTEMBER 26, 2016
- REQUIRES NCSO TO PROVIDE AN INMATE WITH A WRITTEN CONSENT FORM PRIOR TO I.C.E. INTERVIEW
- PROVIDES CRITERIA TO NCSO FOR COOPERATING WITH IMMIGRATION AND CUSTOMS ENFORCEMENT (I.C.E.)
- NCSO ESTABLISHED POLICIES AND PROCEDURES
 - CORRECTIONS POLICY 502
 - ADDRESSES REQUIREMENTS OF GOVERNMENT CODE 7283-7283.2 AND 7282.5

GOVERNMENT CODES

- GOVERNMENT CODE 7282.5
 - IDENTIFIES CHARGES INMATES CAN BE HELD BY LC.E.
- GOVERNMENT CODE 7283
 - DEFINES WHICH INMATES TO INCLUDE DURING COMMUNITY FORUM
- GOVERNMENT CODE 7283.1
 - OUTLINES PROCESS (PROVIDING FORMS, INFORMATION AVAILABILITY, COMMUNITY FORUM)
- GOVERNMENT CODE 7283.2
 - SPECIFIES CHAPTER DOESN'T CHANGE AUTHORITY TO DETAIN BASED UPON AN I.C.E. HOLD



NCSO POLICY 502.3

- NOTIFY INMATE IF JAIL RECEIVES A HOLD REQUEST FROM I.C.E.
 - THIS NOTICE INCLUDES WHETHER NCSO PLANS TO COMPLY WITH THE REQUEST
- INMATE RECEIVES COPY OF I.C.E. REQUEST AS WELL AS ONE OTHER PERSON DESIGNATED BY INMATE IF WE NOTIFY I.C.E. OF THEIR PENDING RELEASE (I.E. AN ATTORNEY)
- ALL I.C.E. REQUESTS FOR INTERVIEWS ARE ENTIRELY VOLUNTARY
- ALL FORMS ARE AVAILABLE IN SEVERAL DIFFERENT LANGUAGES

PROCESS

- INMATE IS BOOKED INTO WBCF
- I.C.E. IS AUTOMATICALLY NOTIFIED VIA LIVESCAN
 - I.C.E. CAN DECIDE TO SEND A DETAINER TO NCSO
- NOTIFICATION OF HOLD IS GIVEN TO INMATE
- IF I.C.E. REQUESTS TO INTERVIEW AN INMATE, CONSENT FORMS ARE GIVEN TO INMATE
 - IF INMATE CONSENTS, THEY ARE INTERVIEWED BY I.C.E., THIS INTERVIEW IS VOLUNTARY.
- I.C.E. RECEIVES NOTIFICATION OF RELEASE FORM IF INMATE MEETS CRITERIA



2022 ICE STATISTICS


- OF THOSE INMATES WITH SOME LEVEL OF I.C.E. INVOLVEMENT, THERE WERE:
 - 8 BOOKINGS TOTAL
 - 0 FEDERAL BOOKINGS
 - 2 WITH HOLDS FROM OTHER AGENCIES
 - OUT OF COUNTY WARRANTS
 - 0 RELEASES
 - 0 RELEASES TO ICE
 - THERE WAS .5 INMATES IN CUSTODY WITH ICE HOLDS ON ANY GIVEN DAY ON AVERAGE IN WBCF
 - 23 DAYS WAS THE AVERAGE LENGTH OF STAY FOR INMATES WITH ICE HOLDS
