OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF AMENDMENT NO 1 TO THE PERSONAL SERVICES CONTRACT WITH SIERRA NEVADA CHILDREN'S SERVICES (SNCS) AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE DEPARTMENT OF SOCIAL SERVICES BUDGET FOR FISCAL YEAR 2018/19 (RESOLUTION 18-151) (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, on April 24, 2018, pursuant to Resolution 18-151, the Board of Supervisors approved the Personal Services Contract with Sierra Nevada Children's Services pertaining to the administration of the Emergency Child Care Bridge Program (Bridge Program) for foster Children for the term of April 1, 2018 through June 30, 2019; and

WHEREAS, the goal of the Bridge Program is to increase the number of foster children successfully placed in home-based family care settings; and

WHEREAS, the Bridge Program has three components: Emergency Child Care Voucher, Child Care Navigator, and Trauma-informed Care Training and Coaching; and

WHEREAS, one of the primary barriers for potential families seeking to take in a foster child is the lack of access to child care immediately following the removal of the child; and

WHEREAS, the funding supports all three of the components of the Bridge Program which will enable families to receive a voucher to help with child care to help decrease the barriers for placement of foster children, and a child care navigator to provide trauma-informed care training and coaching; and

WHEREAS, the Parties desire amend the Agreement to allow additional funding to meet the service needs related to the administration of the Bridge Program.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 01 to the Personal Services Contract by and between the County and Sierra Nevada Children's Services pertaining to services related to administration of the Emergency Child Care Bridge Program for Foster Children (Bridge Program) in the maximum amount of \$137,549 (an increase of \$63,931) for the term of April 1, 2018 through June 30, 2019, and revising Exhibit "B" Schedule of Charges and Payments to reflect the increase in the maximum contract price, be and hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada, and authorizes and directs the Auditor-Controller to amend the Department of Social Services Budget for Fiscal Year 2018/19 as follows:
