RE: CMSP Governing Board- Supervisor Position for Group 1 Counties

As you know, the County Medical Services Program (CMSP) Governing Board is composed of County Supervisors, County Administrative Officers, and county health and welfare officials from the 35 member counties. The Governing Board administers the CMSP program, which provides health care services to indigent adults in the 35 counties.

In fulfillment of its statutory responsibility, the Governing Board has regularized the terms of its Board. The term of the County Supervisor Representative from Group 1 Counties ends on 12/31/17. This position is currently held by County Supervisor Richard Forster of Amador County, who is seeking re-election. Group 1 Counties include the following: Alpine, Amador, Calaveras, Colusa, Del Norte, Glenn, Inyo, Lake, Lassen, Mariposa, Modoc, Mono, Nevada, Plumas, San Benito, Sierra, Siskiyou, Trinity, and Tuolumne.

An election needs to be held to fill the position designated for a County Supervisor from a Group 1 County for a new term, which begins on 1/1/18 and ends on 12/31/20. The Governing Board has directed our office to conduct the election on behalf of the Board. Richard Forster of Amador County is the sole candidate for the position. However, a space is provided on the ballot for write-in candidates


