RESOLUTION APPROVING AMENDMENT NO. 1 TO THE PROFESSIONAL SERVICES CONTRACT BETWEEN USA WASTE OF CALIFORNIA, INC. AND THE NEVADA COUNTY OFFICE OF EMERGENCY SERVICES FOR THE COMMUNITY GREEN WASTE MITIGATION EXTENDING THE CONTRACT TIMELINE THROUGH DECEMBER 31, 2025, AUTHORIZING THE DIRECTOR OF EMERGENCY SERVICES TO EXECUTE THE CONTRACT AMENDMENT

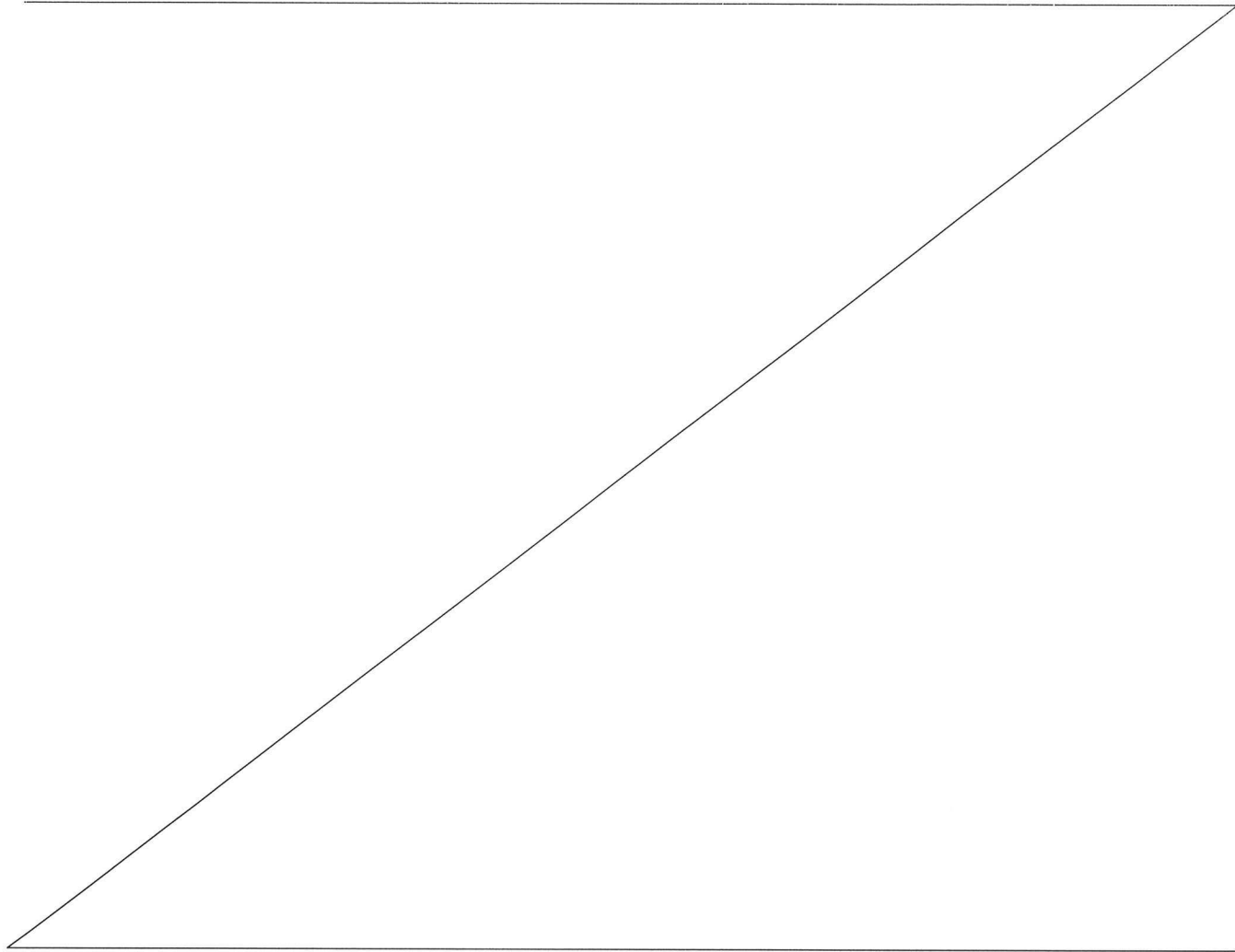
WHEREAS, 92% of properties in Nevada County are in high to very high fire hazard severity zones; and

WHEREAS, providing resources for the community to remove vegetation supports the mission of removing wildfire fuels that improves resiliency; and

WHEREAS, additional resources including free community green waste drop-off events will help reduce fire fuels prior to fire season; and

WHEREAS, the Office of Emergency Services and USA Waste of California collaborated to conduct free green waste drop off events in 2024 (Res. 24-184) and wish to continue this partnership in 2025.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Nevada, State of California, hereby approves Amendment No. 1 to the Professional Services Contract between USA Waste of California, Inc. and the Nevada County Office of Emergency Services for the Community Green Waste Mitigation Project extending the contract timeline through December 31, 2025, authorizing the Director of Emergency Services to execute the contract amendment on behalf of the County of Nevada.

AMENDMENT NO. 1 TO PROFESSIONAL SERVICES CONTRACT
With USA WASTE OF CALIFORNIA, INC.

THIS AMENDMENT is executed this 26th day of November, 2024 by and between USA WASTE OF CALIFORNIA, INC. and COUNTY OF NEVADA. Said Amendment will amend the prior contract between the parties related to the Community Green Waste Mitigation, Scope of Work executed on April 23, 2024 by Resolution No. 24-184.

WHEREAS, the parties desire to amend the contract to extend the contract timeline from December 31st 2024 to December 31, 2025; and

WHEREAS, the current scope of work has a contract end date of 31 December 2024. This will be amended to read December 31, 2025.

NOW, THEREFORE, the parties hereto agree as follows:

1. This Amendment shall be effective as of November 26, 2024.
2. That the contract term will be changed to read "April 23, 2024 to December 31, 2025."
3. That in all other respects the prior contract of the parties shall remain in full force and effect except as amended herein.
