OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 1 TO THE CONTRACT WITH SIERRA MENTAL WELLNESS GROUP FOR THE PROVISION OF CRISIS INTERVENTION SERVICES, COMMUNITY CRISIS SERVICES, AND SERVICES RELATING TO THE OPERATION OF A CRISIS STABILIZATION UNIT (CSU) TO REVISE EXHIBIT "A", SCHEDULE OF SERVICES TO EXPAND CRISIS SERVICES TO INCLUDE 24/7 MOBILE CRISIS RESPONSE PER THE DEPARTMENT OF HEALTH CARE SERVICES (DHCS) DIRECTION IN BHIN 23-025 AND REVISE EXHIBIT "B", SCHEDULE OF CHARGES AND PAYMENTS TO REFLECT THE INCREASE IN THE MAXIMUM CONTRACT PRICE FROM \$3,637,079 TO \$4,559,576 (AN INCREASE OF \$922,497), FOR THE TERM OF JULY 1, 2023 THROUGH JUNE 30, 2024 AND TO AMEND THE FISCAL YEAR 2023/24 BEHAVIORAL HEALTH BUDGET (4/5 VOTE REQUIRED). (RES. 23-307)

WHEREAS, on June 27, 2023 per Resolution RES 23-307 the Nevada County Board of Supervisors authorized the execution of the Professional Services Contract between the County of Nevada and Sierra Mental Wellness Group for services in relation to crisis intervention, community client services, and services relating to the operation of a Crisis Stabilization Unit (CSU); and

WHEREAS, the Department of Health Care Services (DHCS) has required that all county behavioral health systems in California expand their crisis services to provide community- based mobile crisis intervention services 24 hours per day, 7 days per week, 365 days per year; and

WHEREAS, DHCS has required that these services be provided by counties as a Medi-Cal benefit as of December 31, 2023; and

WHEREAS, Sierra Mental Wellness Group has been a longstanding partner with Nevada County Behavioral Health in providing quality services within the behavioral health crisis continuum of care and is qualified to expand crisis care to meet DHCS requirements; and

WHEREAS, the parties desire to amend their Agreement to revise Exhibit "A" Schedule of Services to incorporate the provision of crisis teams available 24/7 to respond within the community to individuals experiencing or at risk of experiencing behavioral health crisis and amend Exhibit "B" Schedule of Charges and Payments to reflect the increase in the maximum contract price to \$4,559,576.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 1 to the Professional Services Contract by and between the County of Nevada and Sierra Mental Wellness Group pertaining to the provision of crisis intervention and community client services for the term of July 1, 2023 through June 30, 2024, in the maximum amount of \$4,559,576 be and hereby is approved, and that the Chair of the Board of Supervisors is hereby authorized to execute the Contract on behalf of the County of Nevada and authorizes and directs the Auditor-Controller to release \$322,874 fund balance in Fund 1481 and amend Behavioral Health's budget as follows:
