OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION ACCEPTING FUNDS FROM THE DEPARTMENT OF FINANCE FOR THE COMMUNITY-BASED TRANSITIONAL HOUSING PROGRAM GRANT AND AUTHORIZING AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE BEHAVIORAL HEALTH DEPARTMENT'S BUDGET FOR FISCAL YEAR 2017/18 (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, Senate Bill 837 established the Community-Based Transitional Housing Program, to be administered by the Department of Finance, for the purpose of providing grants to cities and counties to increase the supply of transitional housing; and

WHEREAS, The Department of Finance is authorized to provide grants of up to \$2 million to cities and counties that operate facilities that provide transitional housing and support services for at least ten years; and

WHEREAS, the Nevada County Behavioral Health Department applied for and was approved for this grant funding for the Community-Based Transitional Housing Grant in the amount of \$1,945,000; and

WHEREAS, The County owns and contracts out the operation of the Bost House, a residential treatment center located in Nevada City; and

WHEREAS, one of the programs planned for the Bost House is transitional housing residential treatment, along with recovery and treatment of alcohol and drug dependency to clients; and

WHEREAS, Community-Based Transitional Housing Funds will be used for the purposes spelled out in Government Code Section 30035.5, including, but not limited to, start up costs, capital improvements, furnishing, community outreach, room and board, law enforcement services, substance use treatment and transitional housing for the Bost House residential treatment center; and

WHEREAS, Government Code Section 30035.5 provides discretion for the funds to be spent on activities the Board of Supervisors believes will contribute to community relations and outcomes related to the Bost House.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Nevada County Board of Supervisors accepts funds from the Department of Finance for the Community-Based Transitional Housing Program Grant in the amount of \$1,945,000.

Funds to be deposited into account 1589-40105-493-1550/445200.

BE IT FURTHER RESOLVED that the Nevada County Board of Supervisors believes the following activities, in addition to those listed in the grant application and the Government Code, will contribute to community relations and enhance outcomes at the facility:

General facility enhancements that may increase capacity, improve functionality, increase security, and promote livability and accessibility in and around the facility.

Costs associated with streamlining access and eligibility for services, including

partnerships with County staff and local law enforcement.

Staff costs associated with administration, outreach and oversight of the program.

BE IT FURTHER RESOLVED that the Nevada County Board of Supervisors authorizes and directs the Auditor-Controller to amend the Behavioral Health Department's Budget for Fiscal Year 2017/18 as follows:

Dear Mr. Gruver:

The Department of Finance is pleased to announce that your application has been reviewed, and that Nevada County has been selected to participate in the Community-Based Transitional Housing Program (Program) with an award of \$1,945,000.

We are in receipt of the resolution adopting the local entitlement. Finance will notify the State Controller's Office (SCO) of your selection to participate in the Community-Based Transitional Housing Program. The SCO will remit to the County \$1,945,000 in Program grant funds. Of the funds provided, \$1,145,000 shall be retained by the County, and the requested \$800,000 shall be provided to the facility operator. We note that the Program Application Review Committee reduced the requested amount by \$55,000 of the \$110,000 submitted for the outdoor cooking area and the backyard recreation.

Please also remember that by August 1, 2018, and each subsequent August 1, both the County and the facility operator are required to provide Finance a report detailing the information required by Government Code section 30035.5 (c). Finance will develop reporting templates for each reporting period.
