RESOLUTION APPROVING AMENDMENT NO. 3 TO THE PERSONAL SERVICES CONTRACT BETWEEN THE COUNTY OF NEVADA AND GEORGE MASON UNIVERSITY TO PROVIDE RNR TOOL (RISK-NEED-RESPONSIVITY) AND SUSTAIN E-LEARNING ACCESS AND INCREASE THE MAXIMUM CONTRACT AMOUNT TO \$82,884

WHEREAS, in 2015 the Probation Department was awarded a Mentally III Offender Crime Reduction (MIOCR) grant (Resolution 15-346); and

WHEREAS, MIOCR monies may be used to expand probation's capacity to effectively case manage youthful offenders suffering from mental illness; and

WHEREAS, the County of Nevada entered into a three-year personal services contract with George Mason University for the provision of a Risk-Need-Responsivity (RNR) program on June 17, 2016 per Purchase Order Number PESL3088; and

WHEREAS, the County of Nevada amended the personal services contract with George Mason University to include the provision of SUSTAIN access, training, and technical assistance, for the provision of a Risk-Need-Responsivity (RNR) program per resolution 18-175 executed on May 8, 2018; and


WHEREAS, the County of Nevada amended the personal services contract with George Mason University to extend the end date of the contract to June 30, 2021 per Resolution 20-181 executed on May 26, 2020; and

WHEREAS, the parties wish to amend the contract maximum to \$82,884 to provide additional RNR Tool and SUSTAIN E-Learning access through George Mason University's Center for Advancing Correctional Excellence, providing continued technical support and access to the SUSTAIN online learning program in an effort to continue to increase the capacity of the Nevada County Probation Department's use of evidence based practices to successfully case manage offenders.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors, of the County of Nevada that Amendment No. 3 to the Personal Services Contract between the County of Nevada and George Mason University increasing the contract amount by \$15,060 to a maximum of \$82,884, and changing the schedule of payments in Exhibit B, hereby is approved, and the Chair of the Board of Supervisors be and hereby authorized to execute Amendment No. 3 on behalf of the County of Nevada.

All services are funded by Community Corrections Performance Incentive funds through the end of the contract term, June 30, 2021.

BE IT FURTHER RESOLVED that the Nevada County Board of Supervisors hereby directs the Auditor-Controller to encumber \$15,060 for Fiscal Year 2020-2021. Funds to be disbursed from 0101-20320-201-1000 / 521520, not to exceed the maximum contract amount of \$82,884.

AMENDMENT #3 TO PERSONAL SERVICES CONTRACT WITH GEORGE MASON UNIVERSITY

THIS AMENDMENT is executed this 1st day of July 2020 by and between GEORGE MASON UNIVERSITY and the COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties for the provision of a Risk-Need-Responsivity (RNR) Program executed on June 17, 2016 by Purchase Order Number PESL3088 and subsequent Amendments No. 1 executed May 8, 2018 by 18-175 and No. 2 executed May 26, 2020 by 20-181.

WHEREAS, the parties desire to amend the contract amount from \$67,824 to \$82,884 to provide additional RNR Tool and SUSTAIN E-Learning access.

NOW, THEREFORE, the parties hereto agree as follows:

- 1. That this amendment shall be effective as of July 1, 2020.
- 2. That paragraph one (1) of Exhibit B maximum amount shall be changed to \$82,884.
- 3. That paragraph one (1) of Exhibit B, shall be amended to reflect an agreement end date of June 30, 2021.
- 4. That the Contractor Responsibility section of Exhibit B shall be modified to add the following:

Fiscal Year 20/21 Costs:

University Personnel Assigned to Project/Administrative Costs:	\$8,052
Additional Year of RNR Tool Access (Up to 50 Users):	\$2,700
Additional Year of SUSTAIN E-Learning Access (up to 7 Users):	\$1,680
RNR and SUSTAIN Software, design, database updates, additions, maintenance:	\$2,628

5. That in all other respects the prior agreements of the parties shall remain in full force and effect except as amended herein.
