



ORDINANCE No. 2446

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

AN ORDINANCE ADDING SUBSECTION J TO SECTION G-IV 3.A.8 OF ARTICLE 3.A OF CHAPTER IV OF THE NEVADA COUNTY GENERAL CODE ADDING A PARKING PROHIBITION ON VIA VISTA – DISTRICT 1

THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA, STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:

SECTION I:

That the addition of a No Parking zone on Via Vista from Ridge Road to approximately 200 feet of its intersection with Echo Ridge Drive be approved based on the following findings A-D:

- A. That Via Vista is a County-maintained roadway; and
- B. That the County has the authority to install signs within its right of way and to enact parking restrictions as needed pursuant to California Vehicle Code section 22507; and
- C. That all of the affected residents in the proposed No Parking zone support the ordinance amendment; and
- D. That the ordinance amendment is needed to protect the rights of residents on Via Vista to access their homes, allow mail delivery, and reduce ongoing noise, traffic, and littering issues.

SECTION II:

Subsection J of Section G-IV 3.A.8, of Article 3.A of Chapter IV of the Nevada County General Code is hereby added as follows:

“* * * *

J. No vehicle shall be parked between the hours of 8 a.m. and 4 p.m. on school days upon the County right-of-way on Via Vista between Ridge Road and 200 feet east of its intersection with Echo Ridge Drive.”

SECTION III:

If any section, sentence, clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional by a decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance. The Board of Supervisors hereby declares that it would have passed this ordinance and adopted this ordinance and each section, sentence, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared invalid or unconstitutional.

SECTION IV:

This Ordinance shall take effect and be in full force thirty (30) days from and after introduction and adoption, and it shall become operative on the 23rd day of Feb., 2018, and before the expiration of fifteen (15) days after its passage it shall be published once, with the names of the Supervisors voting for and against same in the Union, a newspaper of general circulation printed and published in the County of Nevada.
