RESOLUTION AUTHORIZING EXECUTION OF AMENDMENT 1 TO THE CONTRACT WITH NEVADA-SIERRA CONNECTING POINT PUBLIC AUTHORITY FOR THE PROVISION OF SERVICES RELATED TO THE ADMINISTRATION OF EMPLOYMENT SERVICES THROUGH THEIR EMPLOYMENT SERVICES PROGRAM FOR NEVADA COUNTY CALWORKS PARTICIPANTS TO SHIFT FUNDING IN THE AMOUNT OF \$11,792, KEEPING THE MAXIMUM AMOUNT THE SAME AT \$1,548,197, REVISE EXHIBIT "A", SCHEDULE OF SERVICES TO REFLECT THE ADDITION OF A BEHAVIORAL HEALTH CONSULTANT TO PROVIDE THERAPY SERVICES AND REVISE EXHIBIT "B", SCHEDULE OF CHARGES AND PAYMENTS TO REFLECT THE LINE ITEM ADJUSTMENT FOR THE CONTRACT TERM OF JULY 1, 2022 THROUGH JUNE 30, 2023 (RES. 22-371)

WHEREAS, on July 12, 2022, per Resolution 22-371, the Nevada County Board of Supervisors authorized the execution of the Professional Services Contract between the County of Nevada and Nevada-Sierra Connecting Point Public Authority pertaining to services related to the administration of employment services through their Employment Services program for Nevada County CalWORKs participants utilizing the Employability Barrier Removal Program, Work Experience (WEX) and Expanded Subsidized Employment (ESE) Programs; and

WHEREAS, these services benefit CalWORKs participants by increasing their employability in their efforts to become financially self-sufficient and in addition aids the Department of Social Services in meeting its Federal Work Participation Rate (WPR).

WHEREAS, the parties desire to amend their Agreement to shift funding in the line items, keeping the maximum amount the same, revise Exhibit "A" Schedule of Services to incorporate the utilization of a Behavioral Health Consultant and amend Exhibit "B" Schedule of Charges and Payments to shift \$11,792 from the Navigator line to provide for behavioral health support.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Amendment 1 to the Professional Services Contract by and between the County and Nevada-Sierra Connecting Point Public Authority pertaining to the provision of services related to the administration of employment services through their Employment Services program for Nevada County CalWORKs participants utilizing the Employability Barrier Removal Program, Work Experience (WEX) and Expanded Subsidized Employment (ESE) Programs to, revise Exhibit "A", Schedule of Services to reflect the utilization of a Behavioral Health Consultant and revise Exhibit "B", Schedule of Charges and Payments to reflect the shift of funds, \$11,792 from the Navigator line keeping the maximum contract price of \$1,548,197 for the contract term of July 1, 2022 through June 30, 2023 be and hereby is approved and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.
