OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING THE ALLOCATION OF UP TO \$20,000 OF UNEXPENDED FUND FOR SIGNAGE, PARKING, AND ROAD SURAFCE IMPROVEMENTS ON HIRSCHDALE ROAD

WHEREAS, on April 27, 2021, the Board of Supervisors approved an Outdoor Visitor Safety Program Resolution that highlights Community and Economic Resiliency; and

WHEREAS, in 2022, the Board approved a new recreation objective "To promote sustainable recreation in partnership with community providers and other jurisdictions to enhance recreational access, support public health and safety, realize economic opportunities, and preserve natural resource assets"; and

WHEREAS, the Outdoor Visitor Safety Fund Program (Program) as presented to the Board at its January 2022 retreat, is funded by \$400,000 of General Fund and \$450,000 of American Rescue Plan Act (ARPA) funds; and


WHEREAS, at the recent conclusion of the Program's final grant allocation process, there is \$40,000 of unexpended fund remaining in Fiscal Year 2023/24 Recreation budget 0101-70102-325-1000-521520; and

WHEREAS, improvements to Hirschdale Road are consistent with the Program objectives, and planned for the purpose of improving public access to the Tahoe Pyramid Trail; and

WHEREAS, planned improvements on Hirschdale Road are within the County right-ofway and include signage, parking, and road surface improvements.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Finds that proposed improvements to Hirschdale Road are consistent with the Program objectives and that such improvements will provide a public benefit by improving public access to the Tahoe Pyramid Trail.
- 2. Approves allocating up to \$20,000 of the unexpended Outdoor Visitor Safety Fund Program to fund improvements including signage, parking, and road surface improvements on Hirschdale Road along its approach to the Tahoe Pyramid Trail.
