SUBJECT: Resolution to award the contract for the 2025 Road Rehabilitation Project to

George Reed, Inc. for a total amount of \$1,643,381.63 under County Project

Number 450013 – District IV

RECOMMENDATION: Approve the attached resolution.

<u>FUNDING</u>: This contract is contingent upon the adoption of the Fiscal Year 2025/26 County Budget and is included in the Road Capital Improvements proposed budget for Fiscal Year 2025/26. The project is funded by the Road Maintenance and Rehabilitation Account (RMRA) funds. There is no impact to the General Fund.

BACKGROUND: On April 8, 2025, the Nevada County Board of Supervisors approved Resolution 25-117 to authorize the Purchasing Agent to solicit bids for the 2025 Road Rehabilitation Project.

The bids for the project were opened on May 7, 2025, and are listed below:

Bidder	Total Bid
1. George Reed, Inc.	\$1,493,983.30
2. Knife River Construction	\$1,706,596.50
3. Consolidated Engineering, Inc.	\$1,714,390.00
4. Mountain Cascade, Inc.	\$1,726,347.00
5. Martin Brothers Construction	\$1,792,496.00
Engineer's Estimate	\$1,825,000.00

It is recommended that the contract be awarded to the low bidder, George Reed, Inc. at the bid price of \$1,493,983.30, plus a 10% contingency of \$149,398.33 for a total of \$1,643,381.63. Work is expected to begin in July 2025.
