### **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

**RESOLUTION AUTHORIZING RENEWAL OF A CONTRACT  
FOR A VENDOR-HOSTED SOFTWARE SOLUTION BETWEEN  
THE COUNTY OF NEVADA AND GOVERNMENTJOBS.COM  
(DBA NEOGOV), FOR A ONE-YEAR TERM BEGINNING AUGUST  
27, 2024, AND ENDING AUGUST 26, 2025 (FROM SEPTEMBER 22,  
2024 TO AUGUST 26, 2025 FOR CANDIDATE TEXT MESSAGING  
FEATURE), IN THE AMOUNT OF \$159,196.75, WITH AN OPTION  
TO RENEW YEAR TWO AT THE PRICE OF \$172,374.33, AND  
AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS  
TO EXECUTE THE CONTRACT**

WHEREAS, on February 12, 2015, per Resolution 15-026, the Parties entered into an Agreement to provide County of Nevada with software and services commonly known as NeoGov Insight; and

WHEREAS, on July 19, 2016, per Resolution 16-357, the Parties entered into Amendment No. 1 to said Agreement for the purchase of additional software and services called NeoGov Onboard; and

WHEREAS, on October 10, 2017, per Resolution 17-510, the Parties entered into Amendment No. 2 to said Agreement for the purchase of additional software and services called NeoGov Perform; and

WHEREAS, on August 27, 2019, per Resolution 19-484, the Parties entered into Amendment No. 3 to said Agreement for the County's purchase of additional software and services called NeoGov HRIS Core, eForms, and Learn, and the Silver Training Package, effective August 27, 2019; and

WHEREAS, on March 14, 2023, per Resolution 23-118, the Parties entered into said Agreement for the County's renewal of software and services called NeoGov Insight, Onboard, Perform, HRIS Core, eForms, and Learn, and the Silver Training Package, effective August 27, 2022; and

WHEREAS, on August 22, 2023, per Resolution 23-464, the Parties entered into Amendment No. 4 to said Agreement for the County's purchase of additional software and services called NeoGov Attract, effective August 27, 2023.

NOW, THEREFORE BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada that the Contract for a Vendor-Hosted Software Solution by and between the County of Nevada and Governmentjobs.com DBA NEOGOV pertaining to human resources software services in the maximum contract amount of \$159,196.75 for the period of August 27, 2024 to August 26, 2025 (from September 22, 2024 to August 26, 2025 for Candidate Text Messaging feature only), with an option to renew year two at the price of \$172,374.33, be and hereby is approved in the form attached hereto as Exhibit A, and the Chair of the Board of Supervisors is hereby authorized to execute the Contract on behalf of the County of Nevada.
