- Established nationally in 1981;
- NCVRW 2024 Theme:
 Connecting < KINSHIP > Healing
- Mission of NCVRW:
 - To make visible the varying components of victimization and effects of victimization, as well as promote avenues for helping victims recover from crime;
 - To renew our nation's commitment to ensure all victims are informed of their rights and have access to available services; and
 - To honor past crime victims, here and gone.

OUR LOCAL VICTIM WITNESS ASSISTANCE CENTER

- More than 39 years strong;
- Three full time advocates, one part time advocate;
- Grants funded through Victims of Crime Act (VOCA);
- VWAC advocates provided services to 1,237 victims of crime Nevada County, including the Eastern region of Truckee.
- Primary types of services:
 - Court Accompaniment;
 - Information and Referrals;
 - Outreach and Education;
 - California Victim Compensation Board (CalVCB) Assistance; and
 - Emotional Support.
- Sharing resources.





NEVADA COUNTY VICTIM WITNESS ASSISTANCE CENTER LORI NUNNINK, SR. VICTIM ADVOCATE

Current activity:

- Continuing to employ advocate interns through the SkillBridge program;
- Continuing collaboration for the development of a Mass Victimization Response Plan (MVRP), funded through CalOES;
- Developing a formal Nevada County-Court Companion Dog Program (NC-CCD);
- Partnering in the development of a Family Justice Center;
- Continuing cultivation with community partners for the constantly-evolving development of a comprehensive victim advocacy program that meets the needs of the community's increasingly diverse population;
- Partnering with individuals and entities within the community to develop a comprehensive Restorative Justice Program.

- Co-located, multidisciplinary services for victims of family violence and their children to increase safety and support

- Victim informed decision making
